## HOUSE BILL NO. 1010

1 FOR AN ACT ENTITLED, An Act to revise the requirements for the compilation and printing  
2 of the legislative manual referred to as the blue book.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 2-7-3 be amended to read as follows:

5 2-7-3. The legislative manual compiled and printed in each odd-numbered year, ~~other than~~  
6 ~~the year 1975 and every sixth year thereafter~~, shall contain the following data:

7 (1) A current official directory of state government;

8 (2) A current list of county officers;

9 (3) ~~A list of South Dakota post offices;~~

11 sessions during the two years immediately preceding;

15 legislators, public utility commissioners, supreme court justices, circuit court judges,
