- 1 A CONCURRENT RESOLUTION, Urging Congress to fund the Sioux Nation Cultural Center.
- 2 WHEREAS, the United States Congress in Public Law 106-568 established the Wakpa Sica
- 3 Reconciliation Place in Fort Pierre, South Dakota, on behalf of the Great Sioux Nation; and
- 4 WHEREAS, the general goals of the Wakpa Sica Reconciliation Place are to establish a
- 5 Sioux Nation Cultural Center, which will display and interpret tribal history and cultural
- 6 artifacts, enhance further tourism and economic development for tribes and the State of South
- 7 Dakota, and promote general reconciliation and goodwill between Indians and non-Indians; and
- 8 establish the Sioux Nation Supreme Court, which will strengthen tribal sovereignty, enhance
- 9 individual tribal judicial systems, and help to promote economic development for the eleven
- 10 member tribes of the Sioux Nation; and
- WHEREAS, the creation of the Wakpa Sica Reconciliation Place and work conducted by

- 2 non-Indian individuals and organizations throughout the State of South Dakota; and
- WHEREAS, the United States Congress has appropriated \$7.6 million toward the
- 4 construction and work of the Wakpa Sica Reconciliation Place:
- 5 NOW, THEREFORE, BE IT RESOLVED, by the House of Representatives of the Eightieth
- 6 Legislature of the State of South Dakota, the Senate concurring therein, that the South Dakota
- 7 Legislature urges the United States Congress to appropriate such sums as are necessary in Fiscal
- 8 Year 2006 to complete the construction of the Sioux Nation Cultural Center as a component of
- 9 the Wakpa Sica Reconciliation Place project.
