## SENATE BILL NO. 179

Introduced by: Senators Kloucek, Bartling, Jerstad, Katus, Koetzle, Maher, and Sutton and Representatives Lucas, Feinstein, Gassman, Koistinen, Miles, Novstrup (Al), Pederson (Gordon), Sigdestad, and Street

- 1 FOR AN ACT ENTITLED, An Act to increase the veterans bonus payment amount.
- 2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 3 Section 1. That § 33-17-22 be amended to read as follows:
- 4 33-17-22. Any bonus earned pursuant to § 33-17-20 that is based on qualifying service
- 5 during the period September 11, 2001, to a date to be determined by the South Dakota
- 6 Legislature, shall be paid at the rate of one hundred dollars for the first month and twenty dollars
- 7 for each subsequent month of active duty in the armed forces during such period, to a maximum
- 8 bonus of two hundred forty three hundred sixty dollars for service in nonhostile area.
- 9 Section 2. That § 33-17-24 be amended to read as follows:
- 33-17-24. Such bonus shall be paid in the amount of five hundred seven hundred fifty
- dollars to dependents of each member of the armed forces who died as the result of wounds or
- injuries suffered or illness incurred in service that would have qualified for a bonus pursuant to
- 13 § 33-17-20, regardless of the length of such service or regardless of whether or not such service
- was within or without the continental United States.
- 15 Section 3. That § 33-17-24.1 be amended to read as follows:



- 33-17-24.1. Notwithstanding the provisions of §§ 33-17-22 and 33-17-37, if any veteran
- 2 who qualifies for a bonus pursuant to § 33-17-20 is rated ten percent or more disabled for
- 3 service connected disability or disabilities by the veterans administration as a result of wounds
- 4 or injuries or illness incurred while on active duty in the areas or periods specified in § 33-17-20
- 5 regardless of the length of such service, the veteran's bonus shall be in the amount of five
- 6 hundred seven hundred fifty dollars.
- 7 Section 4. That § 33-17-37 be amended to read as follows:
- 8 33-17-37. Any bonus earned pursuant to § 33-17-20 that is based on qualifying service
- 9 during the period from September 11, 2001, to a date to be determined by the South Dakota
- 10 Legislature, shall be paid at the rate of one hundred dollars for the first month and twenty dollars
- for each subsequent month of active duty in the armed forces during such period, to a maximum
- bonus of two hundred forty three hundred sixty dollars. However, any person who qualifies for
- a bonus pursuant to § 33-17-20 and who has received or is eligible to receive the southwest Asia
- service medal, the armed forces expeditionary medal, Kosovo campaign medal, Afghanistan
- 15 <u>campaign medal, Iraq campaign medal, global war on terrorism expeditionary medal, global war</u>
- on terrorism service medal, or other United States campaign or service medal awarded for
- participation outside the boundaries of the United States in combat operations against hostile
- 18 forces for service in the armed forces after January 1, 1993, to a date to be determined by the
- 19 South Dakota Legislature, shall, for the time served in one or more such areas qualifying for any
- of the medals listed in this section, be paid one hundred fifty dollars for the first month and fifty
- 21 dollars for each subsequent month of such service, up to a maximum bonus, together with any
- 22 payments pursuant to this section for service not qualifying for either medal, of five hundred
- 23 <u>seven hundred fifty</u> dollars.
- Section 5. That § 33-17-37.1 be amended to read as follows:

- 1 33-17-37.1. Any veteran who served on active duty after August 2, 1990, and who qualified
- 2 for a veterans bonus as provided by chapter 238 of the 1992 Session Laws and chapter 243 of
- 3 the 1993 Session Laws is eligible to receive a veterans bonus as provided for by chapter 238 of
- 4 the 1992 Session Laws and chapter 243 of the 1993 Session Laws. Any such veteran shall be
- 5 paid at the rates established pursuant to the provisions of this Act.
- 6 Section 6. That § 33-17-38 be amended to read as follows:
- 7 33-17-38. No veteran may receive more than one bonus pursuant to § 33-17-20 for service
- 8 before January 1, 1993, and no veteran may receive more than one bonus for service after
- 9 January 1, 1993. However, any veteran who is eligible for a bonus pursuant to § 33-17-20 for
- service before December 31, 1992, and for service after January 1, 1993, may receive two
- separate bonuses. No single bonus may exceed five hundred seven hundred fifty dollars.
