- 6 assessed value, may not be used for the purpose of valuing other real property. The sale of any
- 7 real property which is not used for the purpose of valuing other real property pursuant to this
- 8 section may not be used in any sales ratio study.
- 9 Section 2. That § 10-6-74 be amended to read as follows:
- 10 10-6-74. Any real property which sells for more than <del>one hundred fifty</del> one hundred seventy
- percent of its assessed value, may not be used for the purpose of valuing other real property. The
- sale of any real property which is not used for the purpose of valuing other real property
- pursuant to this section may not be used in any sales ratio study.
- 14 Section 3. That § 10-6-74 be amended to read as follows:
- 15 10-6-74. Any real property which sells for more than one hundred fifty one hundred eighty

- to this section may not be used in any sales ratio study.
