INTERIM JOINT COMMITTEE ON APPROPRIATIONS TO MEET

PIERRE – The Interim Joint Committee on Appropriations will meet on Wednesday, July 25, 2018, in Pierre. The meeting will be held in Room 362 of the State Capitol at 8:30 AM.

The Interim Joint Committee on Appropriations, co-chaired by Representative David Anderson (R-Hudson) and Senator Larry Tidemann (R-Brookings), will discuss letters of intent that were deferred from the March and June meetings. The committee has invited Terry Paulson, with Paralyzed Veterans of America, to speak about the State Veterans Cemetery fundraising. The committee has also invited Tony Venhuizen, with the Governor's Office, to speak about the South Dakota v. Wayfair case and the implications on general fund revenues. Commissioner Liza Clark, Bureau of Finance and Management, has also been invited to discuss revenues, expenditures, reversions, transfers, and the proration of interest earnings for fiscal year 2018. The Bureau of Finance and Management and the Legislative Research Council will also give an update on fiscal year 2019 general fund revenue projections. The Legislative Research Council fiscal staff will give a brief update on their new role as program evaluators. The meeting is open to the public and the agenda is available on the Legislative Research Council's website.
