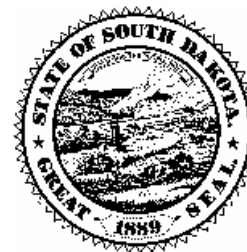

NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Tourism and State Development: Board of Economic Development: (June 18, 2003) intends to adopt rules to implement the Value Added Tourism Sub Fund. The general authority for this rule, as cited by the commission, is SB 58.

A public hearing will be held in LCR 1 & 2, Third Floor, State Capitol Building, Pierre, South Dakota, on July 15, 2003, at 11:00 a.m. CT. A copy of the proposed rules may be obtained without charge from and written comments sent to the Department of Tourism and State Development, Capitol Lake Plaza, 711 East Wells Avenue, Pierre, South Dakota 57501. Written comments must be received by the department no later than July 14, 2003, to be considered. This hearing is being held in a physically accessible place. Persons who have special needs for which the department can make arrangements are asked to call (605) 773-5032 at least 48 hours before the hearing.

Department of Social Services: (June 19, 2003) intends to adopt rules relating to the Medical Services' Program that will incorporate by reference the federal poverty levels established by the federal government; incorporate by reference the latest versions of the Physicians' Current Procedural Terminology (cpt) and the International Classification of Diseases (ICD-9-CM); amend the definition of a "cost outlier"; update the list of Diagnostic Related Groups (DRGs) and their associated weights and lengths of stay and move the list of DRGs to the department's website; change the

reimbursement methodology for out-of-state hospital outpatient services; reduce the rate of reimbursement for inpatient services provided by out-of-state hospitals if the other state's Medicaid program refuses to price the claim; and move the list of outpatient laboratory services and fee schedule to the department's website. The general authority for these rules, as cited by the department, is SDCL 28-6-1 and 28-6-1.1.

A public hearing will be held in Conference Rooms #1, Kneip Office Building, 700 Governors Drive, Pierre, South Dakota, on Thursday, July 10, 2003, at 1:15 p.m. Copies of the proposed rules may be obtained from and written comments sent to Jill Wellhouse, Administrative Rules, Department of Social Services, 700 Governors Drive, Pierre, South Dakota 57501. Written comments must be received by July 21, 2003, to be considered. Individuals intending to present oral testimony at the hearing must make a written copy of their testimony available to the department at the time of the hearing. The testimony must relate directly to the changes being proposed and must cite the specific rule number to which the comments are being directed. This hearing is being held in a physically accessible place. Persons who have special needs for which the department can make arrangements are asked to call (605) 773-3305 at least 48 hours before the hearing.

Department of Social Services: (June 19, 2003) intends to adopt a rule relating to the Food Stamp Program that would consider as exempt the following additional income: charitable donations or assistance used by the household to meet the household's basic needs,

student financial assistance, a gift up to \$100 that is received by a household member as a result of a recurring occasion such as a birthday, and interest income from a source other than a trust. The general authority for this rule, as cited by the department, is SDCL 28-12-1.

A public hearing will be held in Conference Rooms #1, Kneip Office Building, 700 Governors Drive, Pierre, South Dakota, on Thursday, July 10, 2003, at 2:00 p.m. Copies of the proposed rules may be obtained from and written comments sent to Jill Wellhouse, Administrative Rules, Department of Social Services, 700 Governors Drive, Pierre, South Dakota 57501. Written comments must be received by July 21, 2003, to be considered. Individuals intending to present oral testimony at the hearing must make a written copy of their testimony available to the department at the time of the hearing. The testimony must relate directly to the changes being proposed and must cite the specific rule number to which the comments are being directed. This hearing is being held in a physically accessible place. Persons who have special needs for which the department can make arrangements are asked to call (605) 773-3305 at least 48 hours before the hearing.

Department of Social Services: (June 19, 2003) intends to adopt a rule under the authority of the Food Stamp Act of 1977, which establishes the parameters under which the Food and Nutrition Service (FNS) sets the monthly gross and net income eligibility standards for food stamp households based on the established thrifty food plan. The FNS will no longer publish in the Federal Register the annual updates to the monthly gross and net income eligibility standards, the maximum food stamp allotment, and the thrifty food plan. Effective with the publication of the October 30, 2000 Federal Register, the FNS will notify states of the annual updates with a policy memo on the FNS web site at www.fns.usda.gov/fsp. These limits are effective October 1, 2002.

Department of Social Services: (June 19, 2003) intends to adopt a rule under the authority of the Food Stamp Act of 1977, that will prohibit the state agency from increasing a food stamp household's benefits if public assistance benefits that the household is also receiving are reduced under a federal, state, or local means-tested public assistance program because of the failure of a food stamp household member to perform an action required under the assistance program or for fraud. The rule changes are mandatory changes that must be implemented by the State of South Dakota as a condition for a state participating in the Food Stamp Program. These provisions are effective July 1, 2003.
