Representative Shawn Bordeaux, who is chairman of the State-Tribal Relations Committee, requested me to advise you that the committee received testimony at its most recent meeting relative to schools located on reservations in this state struggling to contain the spread of COVID-19 to the point that some schools have felt compelled to transition to distance learning, but distance learning is a poor solution for Native American communities because many students lack the necessary equipment, internet access, or both. Following this testimony, it was proposed that the risk of spreading the COVID-19 virus with inperson learning could be substantially mitigated by administering to students the SalivaDirect test for rapid detection that is described at https://www.fda.gov/news-events/press-announcements/coronavirus-covid-19-update-fda-issues-emergency-use-authorization-yale-school-public-health. As such, the committee has two questions for you at this time, namely:

- 1) Have these tests been made available in this state?
- 2) If yes, can these tests be made available to students on a regular basis?

If you could please e-mail me responses to the above questions at your earliest opportunity, I would appreciate it.
