- [SB 110](#) (Deferred from 31st LD) repeal the limited campaign finance disclosure statement which could be used by certain candidates or candidate campaign committees for legislative office.
- [SB 64*](#) (Deferred from 31st LD) establish certain energy efficiency disclosure requirements for new residential buildings.
- [SB 154*](#) (Deferred from 31st LD) require new construction of certain structures and buildings to comply with the building code.
- [SB 38*](#) (Deferred from 31st LD) require school districts to keep contiguous boundaries when reorganizing.
- [SB 91*](#) ~~(Deferred from 31st LD) allow certain school districts, for a period of five years, to expend capital outlay funds for certain transportation costs, for the purchase of property and casualty insurance, and for energy costs, and the cost of utilities.~~
