[HB 1055](#)* (Deferred from 29th LD) revise certain provisions regarding the appointment of members to the Game, Fish and Parks Commission.

[HB 1095](#) (Deferred from 29th LD) permit local industrial development corporations to conduct bingo games and lotteries under certain conditions.

- [HB 1051](#) (Deferred from 29th LD) revise certain allocations for disabilities in the state aid for special education formula.
- [HB 1052*](#) (Deferred from 29th LD) revise the definition of full-time equivalent to exclude students employed by public postsecondary institutions.

- [HB 1027*](#) (Deferred from 29th LD) authorize the Board of Regents to construct a visitor center on the grounds of McCrory Gardens on the campus of South Dakota State University, to accept donations for such purpose, to make an appropriation therefor, and to declare an emergency.
- [HB 1026*](#) (Deferred from 29th LD)) authorize the Board of Regents to construct phase II of the Electrical Engineering and Computer Science Building on the campus of South Dakota State University, to accept donations for such purpose, to acquire land incidental thereto, and to make appropriations therefor.
- [HB 1001*](#) allow municipalities and counties to issue certain special alcoholic beverage licenses and to repeal certain special alcoholic beverage licenses.
- [HB 1002*](#) (Amended HJ 329) revise certain provisions regarding the days and hours that alcoholic beverages may be sold on a licensed premise and who may sell, serve, or dispense alcoholic beverages on a licensed premise and to revise certain provisions concerning the power of municipalities and counties to regulate the sale and use of alcoholic beverages.
