[SB 62](#)* (Consideration of House Amendment, HJ p. 613) revise the notice requirements for closure of a highway and to provide a civil penalty for failure to comply with a closure.

[SB 121](#)* (Consideration of House Amendment, HJ p. 597, 658)) require the Department of Education to promote certain programs for children who are deaf and hard-of-hearing.

- [HB 1160](#)* (Deferred from 32nd LD) allow certain students to participate in the opportunity scholarship program under certain circumstances.
- [HB 1036](#)* (Deferred from 32nd LD) create a licensing category for the owners of property where licensed gaming is conducted in the city of Deadwood.
- [HB 1046](#)* (Deferred from 32nd LD) revise certain provisions for the procurement of goods and services for governmental agencies.
- [HB 1054](#) (Deferred from 32nd LD) provide independent voters voting absentee the appropriate ballot during a primary election and to declare an emergency.
- [HB 1057](#)* (Deferred from 32nd LD) revise and update certain provisions relating to dairy production and inspection.
- [HB 1105](#)* (Deferred from 32nd LD) permit the record of a person's arrest to be expunged.
- [HB 1107](#)* (Deferred from 32nd LD) ~~require the operation of driver license examination stations in certain locations.~~
~~Permit certain persons to renew an operator's license, motorcycle operator's license, or nondriver identification card without appearing in person at a driver license exam site.~~

- [HB 1214](#)* (Deferred from 32nd LD) allow for the acquisition of the fee ownership of highway right-of way land for certain local governments.
- [HB 1240](#)* (Deferred from 32nd LD) create the South Dakota need-based grant fund, to provide for the awarding of certain need-based grants, and to repeal provisions relating to tuition equalization grants.
- [HB 1241](#)* (Deferred from 32nd LD) establish an additional time period during which fireworks may be sold and discharged and to revise certain provisions regarding county regulation of fireworks.
- [HB 1264](#)* (Deferred from 32nd LD) provide for the issuance of free antlerless deer licenses to certain landowners and lessees.
- [HB 1270](#) (Deferred from 32nd LD) revise the conditions pursuant to which the state may enter into tax collection agreements with Indian tribes.
- [HJR 1004](#) (Deferred from 32nd LD) Proposing and submitting to the electors at the next general election amendments to Article XIII of the Constitution, relating to the trust fund created from the proceeds of the state cement enterprise sales.
