[SB 195*](#) (Consideration of House Amendment, HJ p. 718, 722) ~~revise certain provisions related to tax refunds.~~

~~Revise the refunds for new or expanded agricultural facilities and new or expanded business facilities, to repeal the contractors' excise tax on new or expanded power production facilities, to exempt certain new business facilities from certain tax refunds, and to make certain transfers to the revolving economic development and initiative fund.~~

Revise the refunds for new or expanded agricultural facilities and new or expanded business facilities and to sunset the refunds for new or expanded agricultural facilities and new or expanded business facilities.

[SB 12*](#) (Consideration of House Amendment, HJ p.671, 772, 773, 774) provide for a tiered sex offender registry, to remove certain misdemeanors and juvenile offenses from the sex offender registry, and to establish certain criteria for eligibility to petition for removal or reassignment.

[SB 75*](#) (Consideration of House Amendment, HJ p. 774) ~~define certain terms for livestock identification purposes.~~

- [SB 102*](#) ((Consideration of House Amendment, HJ p. 670, 770) ~~provide for mutual consultation between the Legislature and the Department of Game, Fish and Parks prior to the execution of certain leases.~~
Modify and continue the lease agreement on the Black Hills Playhouse.
- [SB 106*](#) (Consideration of House Amendment, HJ p. 744, 745, 792, 793) authorize the Board of Regents and the Building Authority to contract for construction of classroom facilities at the University Center in Sioux Falls to replace facilities leased from the Sioux Falls School District.
- [SB 172*](#) ((Consideration of House Amendment, HJ p. 778) ~~provide for the assessment of certain agricultural land as noncropland.~~
Revise the definition for environmental upgrades used to provide a property tax exemption for coal-fired power plants.
- [SB 139*](#) (Consideration of House Amendment, HJ p. 717) ~~revise the membership of the State Building Committee created during the planning stages of certain state facilities.~~
Permit the secretary of state to cancel a trademark or service mark registration under certain conditions.
- [SB 104*](#) (Consideration of House Amendment, HJ p. 709, 710) revise certain provisions regarding disclosure of public information and public meetings.
- [SB 22*](#) (Consideration of House Amendment, HJ p. 739, 744) ~~establish a fund for the collection of donations to the birth to three program.~~
Revise the per student allocation in the state aid to general education formula, and to revise certain allocations for disabilities in the state aid to special education formula.
- [SB 67*](#) (Consideration of House Amendment, HJ p. 646) revise the property tax levies for the general fund of a school district.
