- [SB 125\\*](#) revise the time period for computing unemployment insurance employer contribution rates.
- [HB 1010](#) revise the definition of bulk pesticide.
- [HB 1032](#) authorize imposition of a permanent injunction upon any person engaged in an unlicensed real estate appraisal practice.
- [HB 1036](#) revise the time when financial reports of the guaranty association are submitted to the director of insurance.
- [HB 1037](#) revise certain posting requirements relating to hunting in the Black Hills Fire Protection District.

- [SB 97\\*](#) (Deferred from 18<sup>th</sup> LD)revise the membership of certain local boards of equalization.
- [SB 146](#) (Deferred from 18<sup>th</sup> LD)require certain notice requirements for retailers that do not have nexus in South Dakota which are selling tangible personal property, services, or products transferred electronically for use in South Dakota.
- [SB 147](#) (Deferred from 18<sup>th</sup> LD)expand the application of nexus for the purpose of collecting sales and use taxes owed to the state.
- [SB 71](#) prohibit the use of certain handheld electronic wireless devices for electronic messaging while driving.
- [SB 84\\*](#) revise certain provisions regarding administrative penalties when filing campaign finance disclosure statements and to create the election education and compliance fund.
- [SB 103\\*](#) revise certain provisions concerning special alcoholic beverage licenses issued in conjunction with special events.
- [SB 109\\*](#) authorize the secretary of state to promulgate rules concerning lobbyist registration fees, to impose a penalty for the failure to timely file lobbyist or lobbyist employer reports, to repeal certain provisions concerning lobbyists who fail to comply with certain requirements, and to create a technology fund.
- [SB 121\\*](#) authorize an alcoholic beverage retail license for certain malt beverage and wine dealers.
- [SB 126](#) stabilize the funding of the state aid to education formula for two years by appropriating money from the education enhancement trust fund and borrowing money from certain school districts, to create the education stabilization fund, and to prohibit school districts from imposing an excess tax levy for two years.
- [SB 130\\*](#) provide a procedure for the Secretary of State to conduct certain local elections when an emergency exists.
- [SB 152](#) require that any reduction in the general fund levies of a school district only account for increases in the taxable valuation of property and to revise the property tax levies for the general fund of a school district.
