- [SB 126](#) (Deferred from the 23rd LD) stabilize the funding of the state aid to education formula for two years by appropriating money from the education enhancement trust fund and borrowing money from certain school districts, to create the education stabilization fund, and to prohibit school districts from imposing an excess tax levy for two years.
- [SB 114*](#) provide that parties to a divorce or separate maintenance action be restrained from making changes to insurance coverage.
- [SB 136](#) enhance certain provider services.
- [SB 176*](#) provide for the crime of human trafficking, to establish the elements and degrees of the crime, and to provide penalties for the violation thereof.
- [SB 187](#) revise certain provisions regarding the dairy inspection fund.
- [SB 188](#) revise certain provisions regarding the eligibility of National Guard members for certain graduate tuition reductions.
