[HB 1007](#) (Deferred from 28th LD)authorize the South Dakota Building Authority to issue revenue bonds to provide for maintenance and repair on facilities controlled by the Board of Regents and to provide appropriations therefor.

[HB 1047](#) (Deferred from 28th LD)revise certain prairie dog shooting season provisions.

[HB 1070](#)* (Deferred from 28th LD) prohibit school districts from employing school counselors who are not certified.

[HB 1085](#)* (Deferred from 28th LD)prohibit certain political advertising in highway rights-of-way.

[HB 1119](#)* (Deferred from 28th LD) revise the procedure for reissuing certain alcoholic beverage licenses.

[HB 1146](#)* (Deferred from 28th LD)limit copayment or coinsurance amounts for chiropractic services.

[HB 1247](#) (Deferred from 28th LD)make an appropriation to fund property and sales tax refunds for certain elderly persons and persons with a disability.

[HB 1249](#) (Deferred from 28th LD)authorize a carryover of the fiscal year 2011 state aid to special education appropriation to fiscal year 2012.

[HB 1056](#)* (Removed from Consent Calendar)establish an additional time period during which fireworks may be sold and discharged and to revise certain provisions regarding county regulation of fireworks.
