

Division Summaries

1) Labor and Management – Hunter Roberts

The Division of Labor and Management is responsible for administering the state's labor laws. Its mission is to responsively provide dispute resolution and help people through investigations, enforcement, compliance, and education of workforce and discrimination laws

2) Workforce Training – Kendra Ringstmeyer

The Workforce Training Division provides workforce training and education programs including Workforce Innovation and Opportunity Act (WIOA) Title I youth, adult, and dislocated worker programs; Title II Adult Basic Education; General Educational Development (GED®); and the National Career Readiness Certificate (NCRC). It also oversees Trade Adjustment Assistance (TAA), Disability Employment Initiative (DEI), Re-employment Services, and Registered Apprenticeships.

3) Employment Services – Andrew Szilvasi

The role of the Division of Employment Services is to provide the support mechanisms for the Department's workforce services mission. Employment Services oversees several key areas: Jobs for Veterans State Grant, Work Opportunity Tax Credit, Foreign Labor Certification, Temporary Assistance for Needy Families, Senior Community Service Employment Program, and SDWORKS and the Management Information System.

4) Field Operations – Bill McEntaffer

The Division of Field Operations is responsible for the DLR job service offices in communities across the state.

5) Policy and Public Affairs – Dawn Dovre

The Policy and Public Affairs team supports the entire Department though a variety of functions, including communications, media relations, constituent services, legislative activity and organizational development. Its Labor Market Information Center collects, analyzes and provides public information on the labor market of the state.

6) Administrative Services – Emily Ward

Administrative Services is responsible for the internal fiscal and administrative functions of the Department. Its mission is to provide timely and expert fiscal support, information, accounting, printing, purchasing, and property management to DLR staff and partner agencies to fulfill department, state, and federal missions.

7) **Unemployment Insurance** – Pauline Heier

The unemployment insurance (UI) program is designed to provide financial support to workers who have lost their job through no fault of their own. Our mission is to provide economic support to workers and protect the interest of workers and business by determining unemployment insurance eligibility and liability, collecting taxes, making payments, and ensuring compliance all through exceptional service.

8) Banking and Trusts - Bret Afdahl

The mission of the Division of Banking is to charter, license, regulate, and provide guidance to South Dakota financial entities to instill consumer confidence, protect consumer interests, and provide a stable regulatory environment through a balanced and efficient approach.

9) Insurance and Securities – Larry Deiter

The Division of Insurance regulates the insurance and securities industries in South Dakota. Its mission is to protect the public by providing quality assistance, providing fair industry regulation, and promoting healthy and competitive insurance and investment markets.

10) **Boards and Commissions** – Graham Oey and Amber Mulder

The Department provides general administrative and legal support to each of the boards and commissions: Abstracters' Board of Examiners, Board of Accountancy, Athletic Commission, Board of Barber, Cosmetology Commission, Electrical Commission, Plumbing Commission, Real Estate Commission, Board of Technical Professions, and Appraiser Certification Program.
