Notice of Proposed Rules

Water Management Board (Department of Environment and Natural Resources): (October 15, 2020) intends to amend rules to update Ammonia criteria and toxic pollutant criteria; adopt cyanobacteria cyanotoxin criteria; remove the conductivity criteria for irrigation waters; modify the approval procedure for water restoration and enhancement projects; modify the required information to obtain water quality certification; modify the public notice requirements for water quality certifications; update legal references in ARSD 74:51:01; make editorial changes to tables in ARSD 74:51:01; remove lakes with duplicate names; add additional names for certain lakes; add state lake identifier information for each lake; add the immersion recreation use for a segment of Fall River; correct typographical errors and legal locations in ARSD 74:51:03; and update names of certain streams. The general authority for these rules, as cited by the board, is SDCL 34A-2-10, 34A-2-31, 34A-2-33, 34A-2-34, and 34A-2-93.

A public hearing will be held December 2, 2020, at 10:30 a.m. CT at the Matthew Environmental Education and Training Center, 523 East Capitol Avenue, Pierre, South Dakota.
