House Bill 1011

Introduced by: The Committee on Commerce and Energy at the request of the Department of Public Safety

An Act to increase certain boiler inspection fees and dedicate more of the fees to 2 the state's boiler inspection program.

- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA: 3
- **Section 1.** That § 34-29A-35.1 be AMENDED. 4

34-29A-35.1. Inspection fees.

The owner or user of a boiler required by this chapter to be inspected by the chief inspector, or a deputy inspector, shall pay directly to the State of South Dakota through the Office of the State Fire Marshal, upon completion of the inspection, fees in accordance with the following schedule:

(1)Power boilers and high pressure, high temperature water boilers:

4-4-4.6. Transfer of excess funds at end of fiscal year.

At the end of the fiscal year the treasurer shall transfer any cash balance in excess of <u>forty one hundred</u> thousand dollars from the boiler inspection fund to the general fund.
