1 FOR AN ACT ENTITLED, An Act to make an appropriation for Feeding South Dakota and to
2 repeal the sales tax on food refund program.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. Any general funds remaining from the appropriation made in section 3 chapter
5 140 of the 2009 Session Laws shall be reappropriated to the Department of Social Services for
6 a grant to Feeding South Dakota for the purpose of emergency food assistance.

7 Section 2. The secretary of the Department of Social Services shall approve vouchers and
8 the state auditor shall draw warrants to pay expenditures authorized by this Act.

9 Section 3. Any amounts appropriated in this Act not lawfully expended or obligated, shall
10 revert in accordance with chapter 4-8.

11 Section 4. That § 28-1-70 be repealed.

12 ~~—28-1-70. There is established the sales tax on food refund program to be administered by the~~
13 ~~Department of Social Services. The purpose of the program is to provide sales tax refunds on~~



1 food for purchases made in accordance with chapters 10-45 and 10-46 to South Dakota families
2 who need it most.

3 Section 5. That § 28-1-71 be repealed.

4 ~~28-1-71. To be eligible for the sales tax on food refund program, a person shall:~~

5 ~~(1) Be a South Dakota resident;~~

6 ~~(2) Be the head of the household and certify the number of persons in the household;~~

7 ~~(3) Have countable income above one hundred thirty percent and below one hundred
8 fifty-one percent of the federal poverty level, as updated annually by the Department~~

9 ~~of Social Services in administrative rules promulgated pursuant to chapter 1-26;~~

10 ~~(4) Not be a current recipient of supplemental nutrition assistance program benefits.~~

11 Section 6. That § 28-1-72 be repealed.

12 ~~28-1-72. The Department of Social Services shall promulgate rules, pursuant to chapter 1-
13 26, relating to:~~

14 ~~(1) Eligibility criteria;~~

15 ~~(2) Refund amounts or levels;~~

16 ~~(3) Payment provisions;~~

17 ~~(4) Household reporting requirements; and~~

18 ~~(5) Recoveries.~~

19 Section 7. That § 28-1-73 be repealed.

20 ~~28-1-73. To receive sales tax on food refunds pursuant to §§ 28-1-70 to 28-1-77, inclusive,
21 a household shall apply for an annual refund during an annual enrollment period on forms
22 prescribed by the Department of Social Services.~~

23 Section 8. That § 28-1-75 be repealed.

24 ~~28-1-75. The estimate of sales tax on food paid or refund awarded under this program shall~~

1 be determined based on:

2 ~~— (1) — The thrifty food plan as adopted and updated annually in administrative rules~~
3 ~~promulgated by the Department of Social Services pursuant to chapter 1-26; and~~

4 ~~— (2) — The number of individuals in the household.~~

5 ~~— A monthly allotment shall be determined based on the thrifty food plan's maximum~~
6 ~~allotment and the corresponding number of individuals in the household. Once the monthly~~
7 ~~allotment is determined, it shall be annualized and multiplied by the average sales tax rate in~~
8 ~~South Dakota as determined by the Department of Revenue. This shall be the annual level of~~
9 ~~refund eligible for the household.~~

10 Section 9. That § 28-1-77 be repealed.

11 ~~— 28-1-77. The method of payment utilized to make payments authorized by §§ 28-1-70 to 28-~~
12 ~~1-77, inclusive, shall be made by warrant.~~
