3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
4	Section 1. That a NEW SECTION be added:
5	32-1-7. Dealer information available to public.
6	Information regarding dealers licensed pursuant to chapters 32-6B, 32-6C, 32-7A,
7	and 32-7B shall be made available to the public by the department. The information shall
8	include the dealership name, physical address, mailing address, telephone number, dealer
9	license number, and the type of dealer license.
10	Section 2. That § 32-3-30.2 be AMENDED.
11	32-3-30.2. Abstract of title history or damage disclosure statementsFee.
12	The department may, upon written request and payment of a five dollar fee, furnish
13	a person a certified an abstract of the title history which shall include the of any motor
14	vehicle, and semitrailer, or boat registered pursuant to this title including any damage
15	disclosure statements statement of any motor vehicle, trailer, or semitrailer registered
16	under the provisions of this chapter the motor vehicle, and semitrailer, or boat. The
17	abstract may include all documents filed with the department to establish the title history
18	of the vehicle, and semitrailer, or boat. The fee shall be deposited in the state motor
19	vehicle fund. Governmental entities and their subdivisions are exempt from this fee
20	requirement.

32-3A-28. Dealer record of large boats--Inspection by Department of

2 Revenue.

A dealer shall maintain for three <u>five</u> years a record of any large boat bought, sold, exchanged, or received for sale or exchange. <u>This record The dealer</u> shall be open to inspection by <u>allow</u> department representatives <u>to inspect the record</u> during reasonable business hours.

8 **32-3A-59. Seller's books and records--Availability--Retention.**

9 Any seller of a large boat shall, on demand by the secretary of revenue, make 10 available all books, records, and memoranda-which that relate to the sale of a large boat. 11 The secretary, in the event of any failure or refusal to produce such records, may conduct 12 an audit of the books and records of any <u>seller of a</u> large boat dealer failing or refusing to 13 produce such records. All books, records, and memoranda which relate to the sale of a 14 large boat shall be retained by the seller for three five years.

16 **32-5-90.1. Abstract of registration information--Fee.**

17 The department may, upon written request and payment of a two-dollar fee, 18 furnish a person a certified an abstract regarding of the registration information of any 19 motor vehicle, trailer, or semitrailer registered under the provisions of this chapter motor 20 vehicle, and semitrailer, or boat registered pursuant to this title. The fee shall be deposited 21 in the state motor vehicle fund. Governmental entities and their subdivisions are exempt 22 from this fee requirement.

32-6C-6. Books, records, and files to be kept--Inspection.

records, or files, <u>for five years in such the form as prescribed or approved</u> by the
department, <u>including</u> and include the following in the dealer's books, records, or files:

32	2-7A-12. Books, records, and files kept by licensees.
	Any <u>A</u> dealer or manufacturer licensed under the provisions of this chapter ₇ shall
keep	books, records, or files, for five years in such the form as may be prescribed by the
Depai	rtment of Revenue, including and include the following in the dealer's books, records,
<u>or file</u>	<u>'S</u> :
(1)	A record of the purchase, sale, or exchange, of any mobile or manufactured home;
(2)	A description of each mobile or manufactured home purchased, sold, or exchanged,
	together with the name and address of the owner or other person from whom the
	mobile or manufactured home was purchased or received and to whom it was sold
	or delivered. The description shall <u>must</u> include the mobile or manufactured home
	identification number and manufacturer's make and model; and

23 (3)A certificate of title from the previous owner of any mobile or manufactured home 24 not purchased from the manufacturer, from the time the mobile or manufactured 25 home is delivered to the dealer until it has been disposed of by the dealer.

26 The books-and-records, and other papers and documents files shall, at all times during 27 business hours of the day, be subject to inspection by the secretary of revenue.

32-3A-14. Certificate records as public records.

30 The department may upon written request and receipt of a two-dollar fee furnish 31 a person-a certified an abstract regarding registration information of any boat registered 32 under the provisions of this chapter. The fee shall be deposited in the state motor vehicle 33 fund. Governmental entities and their subdivisions are exempt from this fee requirement.

1 Section 10. That § 32-3A-38 be AMENDED.

32-3A-38. Abstract of boat title history.

The department may upon written request and receipt of a five dollar fee furnish a person <u>a certified an</u> abstract of the title history. The abstract may include all documents filed with the department to establish the title history of the boat. The fee shall be deposited in the state motor vehicle fund. Governmental entities and their subdivisions are exempt from this fee requirement.
