On page 1, line 1, of the Introduced bill, after "substances" insert " to those under twenty-one"

On page 1, line 3, of the Introduced bill, after "Dakota:" delete "Section 1. This Act provides provisions regulate certain substances. "

On page 1, after line 3, of the Introduced bill, insert "

Section 1. That a NEW SECTION be added:

34-20B-115. Kratom--Sell--Distribute--Misdemeanor.

No person may sell or distribute kratom to a person under the age of twenty-one. Kratom, for the purposes of this section, is a substance that contains any of the following:

(1) 7-hydroxymitragynine;

(2) Mitragynine; or

(3) Mitragynine pseudoindoxyl.

A violation of this section is a Class 2 misdemeanor.
