- 4 (1) A public utility hookup for water, sewer, and electricity has been stubbed to the land;
- 5 (2) The land is given a zoning classification other than agricultural;
- 6 (3) The land is less than ten acres and does not adjoin any other land under common 7 ownership; or
- 8 (4) The land is platted as a subdivision with three or more lots.

9 For purposes of this section, the term, subdivision, means the division of any tract or parcel of 10 land into two or more lots, sites, or other division for the purpose, whether immediate or future, of 11 sale or building development and includes re-subdivision. The term does not apply to the conveyance 12 of a portion of any previously platted tract, parcel, lot, or site if the conveyance does not cause the 13 tract, parcel, lot, or site from which the portion is severed to be in violation of any existing zoning 14 ordinance or subdivision regulation applying to the tract, parcel, lot, or site."
