On page 1, line 14, of the Introduced bill, after "satisfied" insert ", if the defendant was not driving pursuant to a commercial driver's license at the time of the offense, and only for a defendant's first violation under either chapter 32-25 or a municipal ordinance regulating speed. Thereafter, a further charge for a Class 2 misdemeanor or municipal ordinance regulating speed shall be automatically removed from a defendant's public record after ten years if all court-ordered conditions on the case have been satisfied"
