On page 3, line 5, of the Introduced bill, after "misdemeanor." delete "Section 4. Each county auditor, within thirty days after the effective date on this Act, shall purge the names of all deceased persons from the master registration file. Each county auditor shall certify to

the secretary of state that the auditor has complied with this requirement."
