ten percent of the general fund appropriations from the general appropriation act for the prior fiscal year;

(2) If any unobligated cash balance remains after the requirements of subdivision (1) are met, the commissioner of the Bureau of Finance and Management shall transfer that balance, up to an amount equaling fifteen percent of the general fund appropriations from the general appropriation act for the prior fiscal year, into the trust fund for unclaimed property; and

(3) If any unobligated cash balance remains after the requirements of subdivision (2) are met, the commissioner of the Bureau of Finance and Management shall transfer the remaining amount into the general revenue replacement fund.

Expenditures out of the budget reserve fund shall only be by special appropriation of the Legislature and shall only redress such unforeseen expenditure obligations or such unforeseen revenue shortfalls as may constitute an emergency pursuant to S. D. Const. , Art. III,  $\S 1$ ."
