1-19C-1. Legislative findings regarding offensive geographic place names.

The Legislature finds that all geographic place names containing the <u>term terms</u>, squaw <u>or scalp</u>, are offensive and insulting to all South Dakota's people, history, and

heritage. These All place names containing the term, squaw, have been replaced by names that reflect South Dakota's people, history, and heritage without resorting to harmful or offensive stereotypes, names, words, or phrases. For the same reason, all names of geographic places containing the term, scalp, shall have the term, naca topa, substituted in place thereof, including the following places in Gregory County:

(1) North Scalp Creek to North Naca Topa Creek;

(2) Scalp Butte to Naca Topa Butte;

(3) Scalp Creek Indian Site to Naca Topa Creek Indian Site;

(4) South Scalp Creek to South Naca Topa Creek; and

(5) South Scalp Creek Recreation Area to South Naca Topa Creek Recreation Area.

All state and local government agencies shall make changes to maps and any other reference materials to reflect the changes provided in pursuant to this chapter. The use of the term terms, squaw or scalp, in whole or in part, is

prohibited as a name for any geographic feature within this state.
