HOUSE APPROPRIATIONS ENGROSSED

Introduced by: Representative Tidemann

An Act to authorize the Board of Regents to contract for the design and construction of a new dairy research and extension farm on the campus of South Dakota State University, together with equipment and furnishings, to make an appropriation therefor, and to declare an emergency.

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 6 **Section 1.** The Board of Regents may contract for the design and construction of a new dairy
- 7 research and extension farm on the campus of South Dakota State University in Brookings,
- 8 together with furnishings and equipment, including heating, air conditioning, plumbing, water,
- 9 <u>sewer, electric facilities, sidewalks, parking, landscaping, architectural and engineering</u>
- 10 services, and other services or actions as may be required to accomplish the project.
- 11 **Section 2.** There is hereby appropriated from the general fund the sum of \$1 and the sum of
- 12 \$1 in other fund expenditure authority, together with any additional sums received pursuant
- to section 4 of this Act, for the purposes authorized in section 1 of this Act.
- 14 **Section 3.** The cost estimates contained in this Act have been stated in terms of 2020 values.
- 15 The Board of Regents may adjust such cost estimates to reflect inflation as measured by the
- 16 Building Cost Index, reported by the Engineering News Record, and additional expenditures
- 17 required to comply with regulations adopted after the effective date of this Act. However, any
- 18 adjustments to construction cost estimates for the project may not exceed one hundred
- 19 twenty-five percent of the estimated project construction cost stated in section 1 of this Act.
- 20 **Section 4.** The Board of Regents may accept, transfer, and expend any funds obtained for
- 21 the projects authorized in this Act from federal sources, donations, or any other external
- 22 sources, all of which comprise a special fund for the benefitted project.
- 23 **Section 5.** Notwithstanding §§ 5-14-2 to 5-14-4, inclusive, the Board of Regents shall
- 24 supervise the design and construction of the project authorized in this Act.

- 1 **Section 6.** The executive director of the Board of Regents shall approve vouchers and the
- 2 <u>state auditor shall draw warrants to pay expenditures authorized by this Act.</u>
- 3 **Section 7.** Any amounts appropriated in this Act not lawfully expended or obligated shall
- 4 <u>revert in accordance with the procedures prescribed in chapter 4-8.</u>
- 5 **Section 8.** Whereas, this Act is necessary for the support of the state government and its
- 6 <u>existing public institutions, an emergency is hereby declared to exist, and this Act shall be in</u>
- 7 <u>full force and effect from and after its passage and approval.</u>
