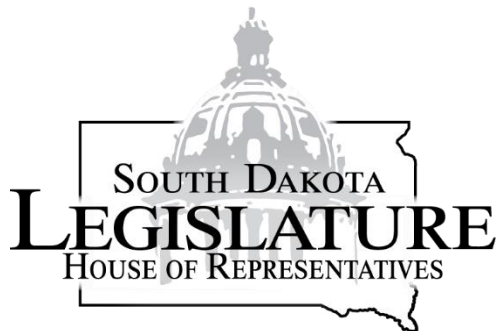

SB 55 authorize certain innovative insurance products and services through insurance innovation waivers. (Senate Commerce and Energy Engrossed)

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

HB 1040 make an appropriation to fund certain small meat processor grants and to declare an emergency. (House Appropriations Engrossed)

HB 1100 (Deferred from 26th LD) (JR 5-17 with pending amendment) modify the medical marijuana program and to create an interim committee to recommend implementation of the medical marijuana program. (House State Affairs Engrossed)

HB 1219 join the Interstate Cooperative Meatpacking Compact. (House Agriculture and Natural Resources Engrossed)

HB 1282 (Deferred from 27th LD) make an appropriation for the purchase of a state airplane and to declare an emergency. (House Appropriations Engrossed)

HB 1139 require that assisted living facilities create and post visitation policies. (House Health and Human Services Engrossed)

HB 1063 make an appropriation to contract for mental health insurance for certain first responder organizations and to declare an emergency. (House Appropriations Engrossed)

HB 1064 make an appropriation for and the establishment of peer support and critical incident stress management training for first responder organizations. (House Appropriations Engrossed)

- HJR 5004 (Deferred from 27th LD) Proposing and submitting to the voters at the 2022 primary election a new section to Article XII of the Constitution of the State of South Dakota, relating to the creation and administration of a trust fund using the net receipts from unclaimed property. (Introduced)
- HB 1165 create the trust fund for unclaimed property and to provide for the transfer of certain unobligated cash balances. (House Appropriations Engrossed)
- HJR 5005 (Deferred from 27th LD) Proposing and submitting to the voters at the 2022 general election a new section to Article XII of the Constitution of the State of South Dakota, relating to the creation and administration of the South Dakota forever trust fund. (Introduced)
- HB 1255 create the South Dakota forever trust fund, to provide for the transfer of certain unobligated cash balances, to transfer moneys thereto, and to declare an emergency. (House Appropriations Engrossed)
- HB 1112 revise the safety zone within which a firearm may be discharged.
(House Agriculture and Natural Resources Engrossed)
- HB 1138 revise provisions regarding the issuance of state park camping permits.
(House Local Government Engrossed)
- HB 1210 make an appropriation to the Board of Regents to provide grant funding for a new bioproducts facility at the research park in Brookings, and to declare an emergency. (House Appropriations Engrossed)
- HB 1146 establish qualifications for members of the Board of Regents.

- HB 1194 authorize the review of certain executive orders issued by the President of the United States. (House State Affairs Engrossed)
- HB 1192 provide for the use of motorized foot scooters.
(House Transportation Engrossed)
- HB 1237 make an appropriation for the purpose of funding county and township roads and bridges and to declare an emergency. (House Appropriations Engrossed)
- HB 1212 clarify the use of force. (House State Affairs Engrossed)
- HB 1154 prohibit employment contracts restricting competitive health care practices.
(House Judiciary Engrossed)
- HB 1189 establish a tribal flag display in the rotunda of the capitol building.
(Introduced)
- HB 1080 increase the enhanced penalty for the crime of simple assault.
(House Judiciary Engrossed) (PJPCE)
- HB 1081 increase the penalty for protection order violations.
(House Judiciary Engrossed) (PJPCE)
- HB 1096 provide a penalty for sexual contact with a minor by a person holding a position of authority. (House Judiciary Engrossed) (PJPCE)
