Senate Bill 195

1 **An Act to appropriate money for the ordinary expenses of the legislative, judicial,**
 2 **and executive departments of the state, the current expenses of state**
 3 **institutions, interest on the public debt, and for common schools.**

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

5 **Section 1.** There is hereby appropriated out of any money in the state treasury not otherwise
 6 appropriated the following sums of money or expenditure authority, or so much thereof as
 7 may be necessary, for the ordinary expenses of the legislative, judicial, and executive
 8 departments of the state, certain officers, boards, and commissions, and support and
 9 maintenance of the educational, charitable, and penal institutions of the state for the fiscal
 10 year ending June 30, 2022.

23 diagnostic laboratory bond redemption and operations fund three million three hundred fifty
24 thousand dollars (\$3,350,000) from the state general fund.

25 **Section 40.** The state treasurer shall transfer to the precision agriculture fund nine hundred
26 thousand dollars (\$900,000) from the state general fund.
