Senate Bill 1**AMENDMENT 1L FOR THE SENATE STATE AFFAIRS BILL**

This bill has been extensively amended (hoghoused) and may no longer be consistent with the original intention of the sponsor.

1 **An Act to provide for the decennial redistricting of the Legislature.**

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 **Section 1. That chapter 2-2 be amended with a NEW SECTION:**
