

## 2022 South Dakota Legislature Senate Bill 43

Introduced by: The Senate Committee on Appropriations at the request of the Board of Regents

## An Act to authorize the Board of Regents to contract for the design, renovation, and construction of an addition for a health sciences center at Black Hills State University-Rapid City, to make an appropriation therefor, and to declare an emergency.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

6 Section 1. The Board of Regents is hereby authorized to contract for the planning, site 7 preparation, renovation, furnishing, equipping, and construction of an addition for a health 8 sciences center at Black Hills State University-Rapid City, together with furnishings and 9 equipment, including heating, air conditioning, plumbing, water, sewer, electric facilities, 10 sidewalks, parking, landscaping, architectural and engineering services, and such other 11 facilities, services or actions as may be required to accomplish the project authorized in this Act, for an estimated cost of \$15,114,644, subject to permitted adjustments pursuant to 12 13 section 3 of this Act. 14 **Section 2.** There is hereby appropriated to the Board of Regents, for the purposes authorized in this Act, the sum of \$8,000,000 in federal fund expenditure authority from the American 15 Rescue Plan Act (ARPA) Capital Projects Fund moneys; the sum of \$5,114,644 in other fund 16 expenditure authority from those portions of the higher education facilities fund allocable to 17 Black Hills State University and South Dakota State University; and the sum of \$2,000,000 in 18 19 other fund expenditure authority from donated funds, together with any additional sums 20 received pursuant to section 4 of this Act, and permitted adjustments pursuant to section 3 21 of this Act. 22 Section 3. The cost estimates contained in this Act have been stated in terms of 2021 values.

23 The Board of Regents may adjust the cost estimates to reflect project inflation as measured

- 24 by the Building Cost Index, reported by the Engineering News Record, and additional
- 25 expenditures required to comply with regulations adopted after the effective date of this Act,
- 26 or additional sums received pursuant to section 4 of this Act. Any adjustments to construction

| 3        | Section 4. The Board of Regents may accept, transfer, and expend any funds obtained for          |

| 6        | into that fund are hereby appropriated to the projects authorized by this Act, subject to the    |
| 7        | limitations stated in sections 1 to 3, inclusive, of this Act.                                   |
| 8        | Section 5. The South Dakota Building Authority may finance the Health Sciences Center            |
| 9        | authorized in section 1 of this Act, including the issuance of higher education facilities fund  |
| 10       | bonds not to exceed a total of \$7,114,644, in accordance with this Act and chapter 5-12.        |

| 11       | Section 6. No indebtedness, bond, or obligation incurred or created under the authority of       |
| 12       | this Act may be or may become a lien, charge, or liability against this state, nor against the   |
| 13       | property or funds of this state, within the meaning of the state's Constitution and laws.        |
| 14       | Section 7. The administration of the design and construction of the project authorized in this   |
| 14<br>15 | Act shall be under the general charge and supervision of the Bureau of Administration as         |

| 17       | Section 8. The executive director of the Board of Regents shall approve vouchers and the         |
