## Section 5. That a NEW SECTION be added to title 13:

For any lawsuit brought or any complaint filed against an accredited school, a school district, or an institution of higher education under the control of either the Board of Regents or the Board of Technical Education, or an employee, board,

or a member thereof, as a result of compliance with section 1 of this Act, the

attorney general shall provide legal representation at no cost to that entity or individual.

<u>In addition to the expenses of representation, the state shall assume financial responsibility</u>

for any other expense related to the lawsuit or complaint and incurred by an accredited school, a school district, or an institution of higher education, or an employee, board, or a member, including any award for attorney's fees and costs for which that entity or individual would be otherwise responsible."
