12 **JOINT SESSION**

14 of receiving a message on the State of the Tribes from the Honorable Delbert Hopkins, Jr., Chairman,
15 Sisseton Wahpeton Oyate. The President of the Senate, Larry Rhoden, presided.

16 The following prayer was delivered by Dave Flute, Secretary, Department of Tribal Relations:

17 Today I am going to send this prayer in our sacred and ancient Dakota language. A beautiful
18 language and a strong language. And finally, a language that was used to help our country win
19 World War II.

20 My prayer will be asking God to look down upon all of us and hear the prayers in all our
21 hearts. Giving thanks for this day and all the many blessings. To look down upon all our leaders and
22 to see the good intentions in all their hearts for the betterment of all our citizens and both of our
23 governments, and to strengthen their purpose and the work they do to keep us safe and healthy.

24 I will pray to the Creator to give wisdom and guidance to our leaders so that we can work
25 together on creating meaningful partnerships to address the drug issues and other challenges we
26 face together as South Dakota citizens, tribal and non-tribal, so that our future generations live in
27 a safe and healthy world.

28 I will ask the Creator to bless all our troops, serving near and far, to keep them safe, to
29 keep their families strong. I will pray for all those challenged with addiction and other illnesses and
30 that God have pity on them and to touch their spirit and heal their body.

31 I will pray for all our spiritual leaders, Tribal, Christians, Catholics, and Jews. Finally, I will
32 pray that God looks upon this entire world and to have pity on all human beings.
