# House Resolution 7001

Introduced by: **Representative Bordeaux**

1 **A RESOLUTION, In support of investigating and opening an official inquiry into the**  
2 **Medals of Honor given to United States soldiers for the involvement and**  
3 **participation of the soldiers in the Wounded Knee Massacre of 1890.**

4 WHEREAS, the United States' highest honor for valor is the Medal of Honor, and Congress  
5 established that, in order to obtain the Medal of Honor, the deed of the person must be so  
6 outstanding that it clearly distinguishes the soldier's gallantry beyond the call of duty from  
7 lesser forms of bravery; and

8 WHEREAS, allowing honor to the Seventh Cavalry for acts in the Wounded Knee Massacre  
9 dishonors the Medal of Honor and is an implication of hostility and genocide against the Great  
10 Sioux Nation and the persons who were killed by the United States at Wounded Knee; and

11 WHEREAS, Chief Big Foot and his band were impeded by Major Whiteside on the Pine  
12 Ridge Indian Reservation at Porcupine Butte, where surrender took place unconditionally  
13 under a white flag of truce, causing Chief Big Foot and his band to be led to Wounded Knee  
14 Creek, where Colonel James W. Forsyth assumed command; and

15 WHEREAS, the Seventh Cavalry stripped the Lakotas of all belongings and disarmed them  
16 of weapons of any kind; a shot was then heard, and the cavalry opened fire indiscriminately  
17 while discharging Hotchkiss cannons, resulting in the killing and wounding of no less than  
18 three hundred unarmed men, women, children, and elderly Lakotas; and

19 WHEREAS, the Seventh Cavalry was recognized to have killed a sizeable number of women  
20 and children by Major General Nelson Miles who said, "[w]holesale massacre occurred and I  
21 have never heard of a more brutal, cold-blooded massacre than that at Wounded Knee"; and

22 WHEREAS, Lakota Holy Man, Black Elk, described Wounded Knee as follows, "I did not  
23 know then how much was ended. When I look back now from this high hill of my old age, I  
24 can still see the butchered women and children lying heaped and scattered all along the

1 crooked gulch as plain as when I saw them with eyes still young. And I can see that something  
2 else died there in the bloody mud and was buried in the blizzard. A people's dream died there.  
3 It was a beautiful dream. And I, to whom so great a vision was given in my youth, you see  
4 me now a pitiful old man who has done nothing, for the nation's hoop is broken and scattered.  
5 There is no center any longer, and the sacred tree is dead"; and

6 WHEREAS, Medal of Honor recipients are under an obligation, through their actions, to  
7 exemplify courage to those who are serving in the Armed Forces and to those who are  
8 planning to serve; and

9 WHEREAS, to date, the Medal of Honor has been bestowed only 3,522 times, including  
10 126 instances for World War I, 145 instances for the Korean War, 23 instances throughout  
11 the Global War on Terror, and 20 times for the Wounded Knee massacre; and

12 WHEREAS, no action has been taken at the federal level to correct this injustice:

13 NOW, THEREFORE, BE IT RESOLVED, by the House of the Ninety-Seventh Legislature of  
14 the State of South Dakota, that efforts be made to investigate each Medal of Honor awarded  
15 to the United States Army members who acted at Wounded Knee Creek, Pine Ridge Agency,  
16 South Dakota on December 29, 1890; and

17 BE IT FURTHER RESOLVED, that the House requests support in this effort from Senators  
18 John Thune and Mike Rounds, and Representative Dusty Johnson, with support from President  
19 Biden, the Commander in Chief; and

20 BE IT FURTHER RESOLVED, that upon approval by the federal government, the name of  
21 each person awarded a Medal of Honor for the acts noted above be removed from the Medal  
22 of Honor Roll enabled under 10 U.S.C. § 1134a.
