On page 1, line 6, of the Introduced bill, after "schools. " delete "A copy of the rules promulgated by the board shall be furnished by the board to the owner or manager of each barbershop and barber school. A copy of the rules shall be posted in a conspicuous place in each barbershop or barber school.

The Board of Barber Examiners may also promulgate rules, pursuant to chapter 1-26, to establish:

- (1) The fee to apply for a certificate of registration for barbers, pursuant to section 3 of this Act;
- (2) The fee to transfer a barber license or registration to this state, pursuant to § 36-14-14;
- (3) The fee for the annual renewal of the certificate of registration for barbers pursuant to §§ 36-14-22 and 36-14-24; and"

On page 1, line 19, of the Introduced bill, after "36-14-24;

(3)" delete "(4) The fee for the operation of a barbershop pursuant to § 36-14-27"

On page 2, line 4, of the Introduced bill, delete "Demonstrates competent, ethical behavior to qualify as a barber, as determined by the Board of Barber Examiners" and insert " Submits an application in compliance with § 36-14-18"

On page 2, line 7, of the Introduced bill, after "college " insert "or school "

On page 2, line 8, of the Introduced bill, delete "Satisfactorily passes" and insert "Passes"

On page 2, line 10, of the Introduced bill, after "barber." delete "Section 3. That a NEW SECTION be added:

"

On page 2, line 11, of the Introduced bill, after "added:" delete "Any person desiring to practice barbering in this state must make an application to the Board of Barber Examiners
The application must:

(1) Contain proof the person met all criteria required pursuant to § 36-14-13

; and

(2) Be accompanied by a fee to be determined by the board, which may not exceed one hundred dollars, pursuant to § 36-14-24."

On page 2, after line 16, of the Introduced bill, insert: "

Section 3. That § 36-14-18 be AMENDED:

36-14-18. Each applicant for an examination or initial registration as a barber pursuant to § 36-14-14 shall make application to the Board of Barber Examiners on ~~blank~~ forms prepared and furnished by the board, setting forth, under oath, the particular qualifications of the applicant, ~~and~~. An applicant by examination shall furnish to the board two five-by-three inch photographs of the applicant, one of which shall be returned to the applicant and presented to the board when the applicant appears for examination. The application shall be accompanied by the required fee."
