On page 1, line 16, of the Introduced bill, after "Act." delete "Section 2. That chapter 34-18 be amended with a NEW SECTION:
"
On page 1, line 17, of the Introduced bill, after "SECTION:" delete "A person selling food or any food product, as authorized in § 34-18-35, shall register with the department and submit an annual fee in the amount of fifteen dollars. The department shall forward any fees collected under this section to the state treasurer for deposit in the general fund.
The department shall promulgate rules in accordance with chapter 1-26, to provide for an annual registration process."
On page 3, line 5, of the Introduced bill, delete "4 " and insert "3 "
On page 3, line 29, of the Introduced bill, after "venue;" insert " or"
On page 3, line 30, of the Introduced bill, after "buyer" delete the semicolon
On page 3, line 31, of the Introduced bill, after "buyer;" delete "(6) The food is sold to the buyer and thereafter delivered to the buyer by mail or other delivery service; or
(7) The food is non-temperature controlled, advertised on a website that contains the labeling information required by § 34-18-37, sold online, and delivered to the buyer by mail or other delivery service"
