On page 1, line 4, of the Introduced bill, after "Dakota:" delete "Section 1. That chapter 13-49 be amended with a NEW SECTION:

On page 1, line 5, of the Introduced bill, after "SECTION:" delete "The universities under the control of the Board of Regents shall receive general funds from the amount appropriated by the Legislature under a formula established by this section. The total allocation of the formula must be based on full-time student equivalents and a per student allocation.

Twenty-five percent of the total allocation of the formula must be distributed equally among the six universities as a baseline for common operations at each university. Seventy-five percent of the total allocation must be distributed based on certain weighted program factors, the number of full-time student equivalents in a university's programs, and a weighted, per student value.

For the purposes of this section, the term, full-time student equivalent, means thirty credit hours of instruction."

On page 1, after line 15, of the Introduced bill, insert: "

Section 1. That chapter 13-49 be amended with a NEW SECTION:

The Board of Regents must provide an annual presentation to the special committee,

created pursuant to § 4-8A-2, no later than November 1 each year, regarding letters or reports requested by the special committee and recommendations from the task force created by Senate Bill 55 enacted in the 2020 legislative session. The provisions of this section are repealed on July 1, 2027.
