#### SD's Food Tax and the Streamlined Sales tax agreement

These are the parts of the Streamlined Sales and Use Tax Agreement that impact food tax repeal options:

## Section 302: STATE AND LOCAL TAX BASES

The tax base for local jurisdictions shall be identical to the state tax base unless otherwise prohibited by federal law.

### Section 308: STATE AND LOCAL TAX RATES

A. No member state shall have multiple state sales and use tax rates on items of personal property or services, except that a member state may impose a single additional rate, which may be zero, on food and food ingredients and drugs as defined by state law, pursuant to the Agreement.

B. A member state that has local jurisdictions that levy a sales or use tax shall not have more than one local sales tax rate or more than one local use tax rate per local jurisdiction.



### History of the Food Tax in South Dakota

- South Dakota began a general state sales tax. It had no exemption for groceries. Thus, the first South Dakota food tax was 2%, generating revenue for the state general fund.
- 1937 State sales tax rate raised to 3%.
- 1941 State sales tax rate reduced to 2%.
- 1955 April thru Dec: The rate was 3% with the additional 1% designated for Korean War bonus.
- 1956 The rate returned to 2% on January 1, 1956.
- 1965 The rate increased to 3%
- 1969 The rate increased to 4%. South Dakota cities began to levy sales tax, with no limit on the rate.
- 1977 City rates were capped at 1%.
- 1983 City rates were allowed to go up to 2%, but limited to 1% on food with the option for no city tax on food. For example, Rapid City chose not to tax food with its city tax. Thus, for years, many cities had general sales tax of 2% with either 1% or 0% on food.
- 1985 Hospitals (but not nursing homes) were granted a tax exemption for their food for patients with public forms of health coverage, including Medicare, Medicaid, Indian Health Service, or "county poor relief" patients.
- 1987 Purchases made with food stamps were exempted from sales tax.
- 1987 A 1% sales tax was added, even on food, and was in effect for 10 months to create a \$40 million pool of funds for new and expanding businesses, known as the REDI Fund.
- 1969, 1978, 1979, 1995, and 1996. The tax base (thus increasing state and city revenue) was expanded, without any reductions in the tax on food. Many more items, mostly services, became subject to SD's sales tax. For examples: newspaper subscriptions, haircuts, taxi fares, snow removal, tree trimming, cell phone bills, funeral services, music lessons and sports coaching.
- 1996 South Dakota is ranked among the top 5 in the "Terrible Ten" states with the most regressive taxes by the Institute on Taxation and Economic Policy (ITEP). South Dakota has remained in the top 5 every year since. The tax on food is one factor contributing to this dishonor.
- The **Streamline Sales Tax Agreement** passed the SD Legislature. States were organizing to allow taxing of sales made over the internet. They were losing significant revenue, and the situation was unfair to local businesses. The Supreme Court had ruled that some standardization was needed in state sales taxes. Enough states subscribing to this agreement would pave the way for states to collect sales tax on these sales. (Update: SB106 passed the 2016 SD Legislature to attempt to collect sales tax from the larger online retailers while waiting for Congress to act.) Certain rules in this agreement affect South Dakota's food tax:
  - -- Items subject to sales tax must be the same for both the state and its cities.
  - -- The state is allowed to have rates on food, medicines and utilities that are different from the general tax rate. This allows states to phase down or phase out their tax on food, as some have done.
  - -- Each city may have only one tax rate. This rule caused a **tax hike on food**, because no cities dropped their tax rate from 2% to 1% on all sales. Rather, most cities took the advice from the state to adopt a revenue-neutral rate between 1% and 2%. Examples: Initially, Sioux Falls went to 1.92%, Mission to 1.75%, Hot Springs to 1.83%.
- 2004 A program began to refund the food tax to low-income households. (Over the 8 years of the program, for many reasons, it never reached more than 5% of the state's low-income non-food-stamp population.)
- A ballot measure to end the food tax failed in the general election, sponsored by the minority Democratic party. The public pinned its hopes on the new refund program. The initiative included no replacement revenue and had strong opposition from the governor. It is notable that despite numerous strikes against it, over one third of the voters supported ending the food tax.
- Since 2004 Most SD cities have raised their rate to 2%. Thus, the tax on food was increased again, to 6% at most grocery stores in the state. In 2016 only Canova (1.95%) and Interior (1.90%) still have rates between 1% and 2%.
- House Bill 1206 ended the food tax refund program, because it was missing over 99% of the state's low-income people and returning to South Dakotans less than 1/10 of 1% of what they were paying in food tax. HB1206 made the fund's remaining \$800,000 available for grants to agencies that actually get food to people in need.
- Fiscal Year 2015. South Dakota's Dept. of Revenue estimates the food tax costs grocery shoppers \$67,039,533 for the state and \$31,173,383 for cities annually.
- 2016 On June 1, 2016, **the tax on food rises** to 6.5% (4.5% state + 2% city) due to the 2016 tax increase for teacher pay, which included no reduction in the tax on food nor an exemption for food in the increase.
