On the Introduced bill, delete everything after the enacting clause and insert:

"

Section 1. There is hereby appropriated from the general fund the sum of \$300,000 to the Board of Regents, for the purpose of awarding, to an accredited tribal university in this state, a grant that is to be used as matching funds under the National Aeronautics and Space Administration-Marshall Space Flight Center's cooperative agreement entitled Enhancing Research in Additive Manufacturing Processes for Lunar Application and Planetary Use in Tribal Housing Development.

Section 2. The executive director of the Board of Regents shall approve vouchers and the state auditor shall draw warrants to pay expenditures authorized by this Act.

Section 3. Any amounts appropriated in this Act not lawfully expended or obligated by June 1330, 2027, shall revert in accordance with the procedures prescribed in chapter 4-8.14.

Section 4. Whereas, this Act is necessary for the support of the state government and its existing public institutions, and emergency is hereby declared to exist, and this Act shall be in full force and effect from and after its passage and approval."
