Senate Bill 198**AMENDMENT 198B FOR THE INTRODUCED BILL**

1 **An Act to ~~revise provisions related to juvenile offenders~~ establish an interim juvenile**
2 **placement committee.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1.** An interim juvenile placement committee is established to consider and develop
5 alternatives for placement of juvenile offenders, develop findings, report on the findings, and
6 recommend legislation. The speaker shall appoint five members of the House of
7 Representatives. The president pro tempore shall appoint five members of the Senate. The
8 Governor shall appoint five individuals with knowledge and experience in juvenile justice. If
9 there is a vacancy on the committee, the vacancy may be filled in the same manner as the
10 original appointment. The committee shall be under the supervision of the Executive Board of
11 the Legislative Research Council and staffed and funded as an interim legislative committee.
12 The committee shall deliver its report and recommended legislation to the Legislature by
13 January 1, 2023.

15 ~~The attorney general may revise the uniform traffic ticket created pursuant to~~
16 ~~chapter 23-1A to be used for juvenile cited violations.~~

17 **~~Section 3. That § 26-7A-10 be AMENDED:~~**

18 ~~**26-7A-10.** If a state's attorney is informed by a law enforcement officer or any~~
19 ~~other person that a child is, or appears to be, within the purview of this chapter and~~
20 ~~chapter 26-8A, 26-8B, or 26-8C, the state's attorney shall make a preliminary~~
21 ~~investigation to determine whether further action shall should be taken. On the basis of~~
22 ~~the preliminary investigation, the state's attorney may:~~

23 ~~(1) Decide that no further action is required;~~

1 ~~(2) If the report relates to an apparent abused or neglected child and if additional~~
2 ~~information is required, refer the matter to the Department of Social Services for further~~
3 ~~investigation and recommendations;~~

4 ~~(3) If the report relates to a juvenile cited violation, proceed on the citation;~~

5 ~~(4) If the report relates to an apparent child in need of supervision, or an apparent~~
6 ~~delinquent child, or a juvenile cited violation, refer the matter to a court services officer~~
7 ~~for any informal adjustment to the supervision of the court that is practicable without a~~
8 ~~petition or refer the matter to a court approved juvenile diversion program for any~~
9 ~~informal action outside the court system that is practicable without the filing of a petition;~~

11 ~~(5)(4) File a petition to commence appropriate proceedings in any case that~~
12 ~~the youth does not meet the criteria provided in § 26-7A-11.1.~~

13 **Section 4. That § 26-7A-11 be AMENDED:**

14 ~~**26-7A-11.** A report of a preliminary investigation involving any apparent child in~~
15 ~~need of supervision, or any apparent delinquent child, or any juvenile cited violation, may~~
16 ~~be referred to a court services officer for informal adjustment or to a court approved~~
17 ~~juvenile diversion program for informal action pursuant to subdivision 26-7A-10(4) under~~
18 ~~§ 26-7A-10 only if:~~

19 ~~(1) The child and the child's parents, guardian, or other custodian were informed~~
20 ~~of their constitutional and legal rights, including being represented by an attorney at every~~
21 ~~stage of the proceedings if a petition is filed;~~

22 ~~(2) The facts are admitted and establish prima facie jurisdiction; and~~

23 ~~(3) Written consent is obtained from the child's parents, guardian, or custodian and~~
24 ~~from the child if the child is of sufficient age and understanding. Efforts to effect informal~~
25 ~~adjustment or informal action may extend no longer than four six months from the date~~
26 ~~of the consent.~~

27 ~~The state's attorney may include in the referral to a court approved juvenile~~
28 ~~diversion program a requirement that restitution as defined in subdivision 23A-28-2(4) be~~
29 ~~imposed as a condition of the diversion program.~~

30 **Section 5. That § 26-7A-11.1 be REPEALED:**

31 ~~Any apparent child in need of supervision or any apparent delinquent child shall be~~
32 ~~referred for informal adjustment or informal action pursuant to subdivision 26-7A-10(4) if~~
33 ~~the following criteria are met:~~

1 ~~(1) The child has no prior adjudications;~~

2 ~~(2) The child has had no informal adjustment or informal action within the last~~
3 ~~twelve months;~~

4 ~~(3) The child is an apparent child in need of supervision pursuant to § 26-8B-2 or~~
5 ~~an apparent delinquent pursuant to § 26-8C-2 and the alleged conduct constitutes a~~
6 ~~misdemeanor;~~

7 ~~(4) The child's alleged conduct did not include use of violence or force against~~
8 ~~another; and~~

9 ~~(5) All of the requirements in § 26-7A-11 are met.~~

10 ~~If the state's attorney has good cause to believe that informal adjustment or~~
11 ~~informal action is insufficient to meet the purposes of this chapter and chapters 26-8B and~~
12 ~~26-8C, the state's attorney may file a delinquency or child in need of supervision petition~~
13 ~~pursuant to subdivision 26-7A-10(5). The petition shall include notice of the departure~~
14 ~~from informal adjustment or informal action and notice to the child of the child's right to~~
15 ~~move for informal adjustment or informal action. Upon motion of the child and upon a~~
16 ~~finding that no good cause exists, the court may refer the child to informal adjustment or~~
17 ~~informal action pursuant to subdivision 26-7A-10(4).~~

18 **~~Section 6. That § 26-7A-125 be REPEALED:~~**

19 ~~The Supreme Court shall establish rules, pursuant to § 16-3-1, to develop a~~
20 ~~graduated sanctions and incentives procedure and grid to guide court services officers in~~
21 ~~determining the appropriate response to a violation of terms or conditions of probation in~~
22 ~~juvenile cases. If the graduated sanctions program includes detention, a stay may not~~
23 ~~exceed forty eight hours, and may not exceed twenty four hours for children in need of~~
24 ~~supervision pursuant to § 26-8B-3. The Unified Judicial System shall collect data related~~
25 ~~to the use of sanctions, grid compliance and program outcomes, and shall include a~~
26 ~~process for reviewing sanctions that are challenged by the juvenile. The system of~~
27 ~~graduated sanctions shall be created with the following objectives:~~

28 ~~(1) Responding to violations of probation quickly, consistently, and proportionally;~~

29 ~~(2) Reducing the time and resources expended by the court to respond to~~
30 ~~violations; and~~

31 ~~(3) Reducing the likelihood of a new delinquent act.~~

32 **~~Section 7. That § 26-7A-126 be REPEALED:~~**

1 ~~The following allegations of delinquency and children in need of supervision shall~~
2 ~~be treated as juvenile cited violations by law enforcement:~~

3 ~~(1) Petty theft in the second degree pursuant to § 22-30A-17.3;~~

4 ~~(2) Intentional damage to property, four hundred dollars or less, pursuant to § 22-~~
5 ~~34-1;~~

6 ~~(3) Purchase, possession, or consumption of alcoholic beverage by person under~~
7 ~~twenty one years pursuant to § 35-9-2 in accordance with subdivision 26-8B-2(5); and~~

8 ~~(4) Truancy pursuant to subdivision 26-8B-2(1).~~

9 ~~The issuing officer shall notify the child and the child's parent, guardian, or~~
10 ~~custodian that a hearing on the citation for a cited violation shall be held before a judicial~~
11 ~~circuit court judge within ten days of issuance of the citation or on the next available court~~
12 ~~date and be treated as a confidential juvenile matter. The hearing shall be held pursuant~~
13 ~~to § 26-7A-36 and the case records shall be treated as confidential consistent with the~~
14 ~~provisions of §§ 26-7A-114, 26-7A-115, 26-7A-116, 26-7A-120, and 26-7A-27. A cited~~
15 ~~violation is not an adjudication or a child in need of supervision or delinquency proceeding.~~

17 ~~report with the state's attorney. A report may also be filed with the state's attorney in lieu~~
18 ~~of a citation if the conduct occurs in conjunction with another offense that is not subject~~

20 **~~Section 8. That § 26-7A-127 be REPEALED:~~**

21 ~~If a state's attorney is informed that a citation or report has been issued for a~~
22 ~~juvenile cited violation, the state's attorney may take any action permitted pursuant to~~
23 ~~§ 26-7A-10, except that a state's attorney may only file a petition pursuant to subdivision~~
24 ~~26-7A-10(5) if:~~

25 ~~(1) The child is cited or a report is filed pursuant to subdivision 26-7A-126(1), (2),~~
26 ~~or (4); or~~

27 ~~(2) The child is cited pursuant to subdivision 26-7A-126(3), and has two or more~~
28 ~~prior judgments for the same violation.~~

29 ~~If the state's attorney intends to proceed on a petition for a violation of the~~

32 **~~Section 9. That § 26-7A-128 be REPEALED:~~**

1 ~~If the state's attorney elects to proceed on the citation pursuant to subdivision 26-~~
2 ~~7A-10(3), the child shall be asked for an admission or denial of the alleged violation. If~~
3 ~~the child admits to the violation, the court shall accept the admission and enter a judgment~~
4 ~~pursuant to § 26-7A-129. If the child denies committing the violation, the case may be~~
5 ~~tried according to procedure adopted by the presiding judge of each judicial circuit and~~
6 ~~approved by the Supreme Court, but a jury trial may not be granted.~~

7 ~~If the child fails to appear in court at the time set in the citation or set by~~
8 ~~subsequent postponement, the court may either issue a summons to appear and set a~~
9 ~~new date for hearing to show cause, the court may consider that failure to appear~~
10 ~~constitutes an admission to the allegations contained in the complaint and may accordingly~~

17 **~~Section 10. That § 26-7A-129 be REPEALED:~~**

18 ~~If a child is found to be in violation of the citation, the court shall enter a judgment~~
19 ~~against the child for one or more of the following:~~

20 ~~(1) Require the child to complete a court approved juvenile diversion program or~~
21 ~~informal adjustment administered by a court services officer;~~

22 ~~(2) A fine and court costs not to exceed one hundred dollars;~~

23 ~~(3) Community service;~~

24 ~~(4) Restitution as defined in subdivision 23A-28-2(4) and as determined~~
25 ~~appropriate by the court; or~~

26 ~~(5) Suspension or revocation of the child's driving privilege if the judgment is~~
27 ~~entered on a violation pursuant to subdivision 26-7A-126(3).~~

28 ~~The court may set a hearing to review compliance with the judgment. If a child is~~
29 ~~unable to pay a fine, court costs, or restitution as ordered by the court, any party may~~
30 ~~request that the court order community service in lieu of the monetary judgment. At no~~
31 ~~time may a court order a child to probation or detention upon entry of a judgment on a~~
32 ~~cited violation. A judgment on a cited violation shall be a confidential matter pursuant to~~
33 ~~subsection 15-15A-7(p) but the state's attorney may maintain a nonpublic record of the~~
34 ~~judgment for purposes of determining eligibility under § 26-7A-127.~~

1 **Section 11. That § 26-8B-1 be AMENDED:**

2 ~~26-8B-1.~~ It is the purpose of this chapter, in conjunction with chapter 26-7A, to
3 establish an effective state and local system for children in need of supervision, including
4 a focus on community-based rehabilitation.

5 **Section 12. That § 26-8B-4 be AMENDED:**

6 ~~26-8B-4.~~ Following adjudication of a child as a child in need of supervision, the
7 court may continue the case and may require a court services officer to present to the
8 court a plan of disposition. If a community response team as defined in § 26-8D-1 has
9 been established, prior to any disposition to the Department of Corrections, the court may
10 seek a recommendation for a viable community alternative disposition from the team. If
11 the team is unable to provide any recommendation within seven days of the referral, the
12 court may exercise its discretion and make a disposition decision without the input of the
13 team, pursuant to § 26-8B-6. In all cases, the court may adopt the recommendation of
14 the team in part, in full, or reject the recommendation of the team in its entirety.

15 **Section 13. That § 26-8B-6 be AMENDED:**

16 ~~26-8B-6.~~ If a child has been adjudicated as a child in need of supervision, the
17 court shall enter a decree of disposition according to the least restrictive alternative
18 available in keeping with the best interests of the child. The decree shall contain one or
19 more of the following:

20 (1) The court may place the child on probation pursuant to § 26-8B-8 or under
21 protective supervision in the custody of one or both parents, guardian, custodian, relative,
22 or another suitable person under conditions imposed by the court;

23 (2) The court may require as a condition of probation that the child participate in a
24 supervised community service report for assignment to a supervised work program,
25 provided the child is not placed in a detention facility and is not deprived of the schooling
26 that is appropriate to the child's age, needs, and specific rehabilitative goals. The
27 supervised community service work program shall be of a constructive nature designed to
28 promote rehabilitation, shall be appropriate to the age level and physical ability of the
29 child, and shall be combined with counseling by a court services officer or other guidance
30 personnel. The supervised community service program assignment shall be made for a
31 period of time consistent with the child's best interests, but may not exceed ninety days;

1 ~~(3) If the court finds that the child has violated a valid court order, the court may~~
2 ~~place the child in a detention facility for not more than seven ninety days, including any~~
3 ~~period of temporary custody pursuant to § 26-8B-3, for purposes of disposition if:~~

4 ~~(a) The child is not deprived of the schooling that is appropriate for the child's age,~~
5 ~~needs, and specific rehabilitative goals;~~

6 ~~(b) The child had a due process hearing before the order was issued; and~~

7 ~~(c) A plan of disposition from a court services officer is provided to the court.~~

8 ~~The issued order must identify the violated court order, determine detention is the~~
9 ~~best available placement, specify the length of time the child is to be held in detention,~~
10 ~~and outline the plan for release of the child from detention;~~

11 ~~(4) The court may commit the child to the Department of Corrections for placement~~
12 ~~in a juvenile correctional facility, foster home, group home, group care center, residential~~
13 ~~treatment center, or other community based services, if those community based services~~
14 ~~were not provided prior to commitment, pursuant to chapter 26-11A. Prior to placement~~
15 ~~in a juvenile correctional facility, an interagency team comprised of representatives from~~
16 ~~the Department of Human Services, Department of Social Services, Department of~~
17 ~~Education, the Department of Corrections, and the Unified Judicial System shall make a~~

26 ~~(6)(7) — The court may order the child to be examined and treated at the Human~~
27 ~~Services Center;~~

28 ~~(7)(8) — The court may impose a fine not to exceed five hundred dollars;~~

29 ~~(8)(9) — The court may order the suspension or revocation of the child's right to~~
30 ~~apply for a driving privilege, suspend or revoke an existing driving privilege, or restrict~~
31 ~~the privilege in such manner as the court sees fit or as required by § 32-12-52.4, including~~
32 ~~requiring that financial responsibility be proved and maintained; or~~

33 ~~(9)(10) — The court may assess or charge the same costs and fees as permitted~~

18 **~~Section 14. That § 26-8B-8 be AMENDED:~~**

19 ~~**26-8B-8.** The terms and, conditions, and duration of probation of a child in need~~
20 ~~of supervision shall be specified by rules or orders of the court and by a court services~~
21 ~~officer.~~

22 ~~The duration of juvenile probation shall be specified by order of the court but may~~
23 ~~not exceed six months unless:~~

24 ~~(1) The child is placed in the intensive juvenile probation program; or~~

25 ~~(2) The child's probation is extended as provided under this section.~~

26 ~~If the child is placed on intensive juvenile probation, the duration of probation~~
27 ~~ordered by the court may be up to twelve months.~~

28 ~~If the child is placed on juvenile probation, a court services officer may request two~~
29 ~~extensions up to six months each or one extension up to six months for intensive juvenile~~
30 ~~probation. The court may authorize the same in accordance with Unified Judicial System~~
31 ~~procedure if the extension is necessary for the child to complete evidence-based treatment~~
32 ~~as required by the case plan. If evidence-based treatment is not available, an extension~~
33 ~~may be granted if the youth is engaged in alternative court-approved treatment that will~~
34 ~~not be completed before the previously ordered term of probation expires.~~

1 ~~The total duration of probation, including juvenile intensive probation and~~
2 ~~extensions in all cases, may not exceed eighteen months unless the court provides written~~
3 ~~authorization to allow a child to complete evidence-based treatment that will not be~~
4 ~~completed before probation expires. Probation may not be extended solely to collect~~
5 ~~restitution. If probation is terminated with restitution owing, Unified Judicial System~~
6 ~~procedure may govern the collection.~~

7 ~~Each child placed on probation shall be given a written statement of the terms and~~
8 ~~conditions of probation and the probation policy. The terms and conditions, as well as the~~
9 ~~probation extension policy, shall be explained to the child.~~

10 ~~The court shall review the terms and conditions of probation and the progress of~~
11 ~~each child placed on probation at least once every six months. The court may release a~~
12 ~~child from probation or modify the terms and conditions of the child's probation at any~~
13 ~~time, but any child who has complied satisfactorily with the terms, conditions, and~~
14 ~~duration of probation shall be released from probation and the jurisdiction of the court~~
15 ~~terminated. If the duration of probation previously prescribed has expired, the court shall~~
16 ~~release the child from probation and terminate jurisdiction.~~

17 **~~Section 15. That § 26-8B-9 be AMENDED:~~**

18 ~~**26-8B-9.** The following provisions apply if the child is alleged to have violated the~~
19 ~~terms and conditions of probation and a formal petition is filed with the court:~~

20 ~~(1) The court shall set a hearing on the alleged violation and shall give five days'~~
21 ~~notice to the child, to the child's parents, guardian, or custodian, and to any other parties~~
22 ~~to the proceedings;~~

23 ~~(2) The child and the child's parents, guardian, or custodian shall be given a written~~
24 ~~statement concerning the alleged violation;~~

25 ~~(3) The child may be represented by legal counsel at the probation violation hearing~~
26 ~~and the child is entitled to the issuance of compulsory process for the attendance of~~
27 ~~witnesses;~~

28 ~~(4) If the court finds by a preponderance of the evidence that the child violated the~~
29 ~~terms and conditions of probation, the court may modify the terms and conditions of~~
30 ~~probation, revoke probation, or take other action as permitted by this chapter or chapter~~
31 ~~26-7A, according to the least restrictive alternative which is in the best interests of the~~
32 ~~child and the public, except commitment to the Department of Corrections. The court~~
33 ~~may only commit a child to the Department of Corrections if the court finds that the~~

2 ~~circumstances provided in subdivision 26-8B-6(10) exist and the state; and~~

3 ~~(5) For the purposes of this section, a new law violation is defined as delinquent~~
4 ~~behavior pursuant to § 26-8C-2, a Class 1 misdemeanor violation of title 32, or a violation~~
5 ~~of § 32-23-21; and~~

6 ~~(6) If the court finds that the child did not violate the terms and conditions of~~
7 ~~probation as alleged, the court shall dismiss the proceedings and continue the child on~~
8 ~~probation under the terms, and conditions, and duration previously prescribed. If the~~
9 ~~duration of probation previously prescribed has expired, the court shall release the child~~
10 ~~from probation and terminate jurisdiction.~~

11 **Section 16. That § 26-8C-1 be AMENDED:**

12 ~~**26-8C-1.** It is the purpose of this chapter, in conjunction with chapter 26-7A, to~~
13 ~~establish an effective state and local system for delinquent children including a focus on~~
14 ~~community-based rehabilitation.~~

15 **Section 17. That § 26-8C-5 be AMENDED:**

16 ~~**26-8C-5.** Following adjudication of a child as a delinquent child, the court may~~
17 ~~continue the case and may require a court services officer to present to the court a plan~~
18 ~~of disposition. Where a community response team as defined in § 26-8D-1 has been~~
19 ~~established, prior to any disposition to the Department of Corrections, the court may seek~~
20 ~~a recommendation for a viable community alternative disposition from the team. If the~~
21 ~~team is unable to provide any recommendation within seven days of the referral, the~~

29 ~~with the best interests of the child. The decree shall contain one or more of the following:~~

1 ~~(1) The court may require the child to pay restitution, as defined in subdivision~~
2 ~~23A-28-2(4) and under conditions set by the court, if payment can be enforced without~~
3 ~~serious hardship or injustice to the child;~~

4 ~~(2) The court may make any one or more of the dispositions in § 26-8B-6, except~~
5 ~~that a delinquent child may be incarcerated in a detention facility established pursuant to~~
6 ~~provisions of chapter 26-7A for not more than ninety days, which may be in addition to~~
7 ~~any period of temporary custody;~~

8 ~~(3) The court may impose a fine not to exceed one thousand dollars;~~

9 ~~(3)(4) — The court may place the child on probation under the supervision of a~~
10 ~~court services officer or another designated individual pursuant to § 26-8C-14;~~

11 ~~(4) The court may require a child. The child may be required as a condition of~~
12 ~~probation to participate in report for assignment to a supervised community service work~~
13 ~~program, if the child is not deprived of the schooling that is appropriate for the child's age,~~
14 ~~needs, and specific rehabilitative goals. The supervised community service work program~~
15 ~~shall be of a constructive nature designed to promote rehabilitation, appropriate to the~~
16 ~~age level and physical ability of the child, and shall be combined with counseling by the~~
17 ~~court services officer or other guidance personnel. The supervised community service work~~
18 ~~program assignment shall be made for a period of time consistent with the child's best~~
