1 FOR AN ACT ENTITLED, An Act to revise the requirements for health maintenance
2 organizations.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 58-41-1 be amended to read as follows:

5 58-41-1. Terms used in this chapter, ~~unless the context otherwise requires,~~ mean:

- 6 (1) "Comprehensive health maintenance services," a set of comprehensive health
7 services which the enrollees might reasonably require to be maintained in good
8 health, including as a minimum, but not limited to, emergency care, inpatient hospital
9 and physician care, outpatient medical services, and preventive medical services;
- 10 (2) "Director," the director of the Division of Insurance or his designee;
- 11 (3) "Enrollee," any person who has entered into, or is covered by a health maintenance
12 contract;
- 13 (4) "Evidence of coverage," any certificate, agreement, or contract issued to an enrollee
14 which sets out the coverage to which he is entitled under the health maintenance
15 contract which covers him;



1 (5) "Health maintenance contract," any contract whereby a health maintenance
2 organization agrees to provide comprehensive health maintenance services to
3 enrollees, provided that the contract may contain reasonable enrollee copayment
4 provisions. Any contract may provide for health care services in addition to those set
5 forth in subdivision (1);

6 (6) "Limited health service," dental care services, vision care services, mental health
7 services, substance abuse services, pharmaceutical services, podiatric care services,
8 and such other services as may be determined by the director to be limited health
9 services. Limited health service does not include hospital, medical, surgical, or
10 emergency services except as these services are provided incident to the limited
11 health services;

12 (7) "Provider," any person who furnishes health services and is licensed or otherwise
13 authorized to render such services in the state;

14 ~~(7) "Secretary," the secretary of the Department of Health or his designee~~

15 (8) "Risk bearing entity," an intermediary organization that is a financial risk for services
16 provided through contractual assumption of the obligation for the delivery of
17 specified health care services to covered persons of the health maintenance
18 organization.

19 Section 2. That § 58-41-2 be amended to read as follows:

20 58-41-2. As used in this chapter, ~~unless the context otherwise requires,~~ a "health
21 maintenance organization" is a corporation organized under Title 47, controlled and operated
22 as provided in this chapter, which provides, either directly or through arrangements with
23 providers or other persons, comprehensive health maintenance services, or arranges for the
24 provision of such services, to enrollees on the basis of a fixed prepaid sum without regard to the

1 frequency or extent of services furnished to any particular enrollee. A health maintenance
2 organization may be organized pursuant to this chapter on a limited health service basis.
3 Nothing in this chapter prohibits a health maintenance organization holding a certificate of
4 authority in this state from issuing contracts to enrollees on a preferred provider, exclusive
5 provider, or closed panel basis.

6 Section 3. That § 58-41-6 be amended to read as follows:

7 58-41-6. Each application for a certificate of authority shall be verified by an officer or
8 authorized representative of the applicant, shall include an application fee, and shall be in a form
9 prescribed by the director. Each application shall include the following:

- 10 (1) A copy of the basic organizational document, if any, of the applicant, such as the
11 articles of incorporation, or other applicable documents, and all amendments thereto;
- 12 (2) A copy of the bylaws, rules, and regulations, or similar document, if any, and all
13 amendments thereto which regulate the conduct of the affairs of the applicant;
- 14 (3) A list of the names, addresses, and official positions of all members of the board of
15 directors, and the principal officers of the organization, which shall contain a full
16 disclosure in the application of the extent and nature of any contract or financial
17 arrangements between them and the health maintenance organization, including a full
18 disclosure of any financial arrangements between them and any provider or other
19 person concerning any financial relationship with the health maintenance
20 organization;
- 21 (4) A statement generally describing the health maintenance organization, its health care
22 plan or plans, facilities, and personnel, including a statement describing the manner
23 in which the applicant proposes to provide enrollees with comprehensive health
24 maintenance services or limited health services;

- 1 (5) A statement reasonably describing the geographic area or areas to be served and the
2 type or types of enrollees to be served;
- 3 (6) A description of the complaint procedures to be utilized;
- 4 (7) A description of the procedures and programs to be implemented to meet the
5 requirements of subdivisions 58-41-12(2) and (3) and chapters 58-17G and 58-17H
6 and to monitor the quality of health care provided to enrollees;
- 7 (8) A description of the mechanism by which enrollees will be afforded an opportunity
8 to participate in matters of policy and operation under §§ 58-41-23 and 58-41-24;
- 9 (9) Such other information as the director may reasonably require to be provided;
- 10 (10) A copy of the form of any contract made, or to be made, between the applicant and
11 any providers regarding the provision of limited health services to enrollees;
- 12 (11) A copy of the form of any contract made, or to be made, between the applicant and
13 any person listed in subdivision (3) of this section;
- 14 (12) A copy of the form of any contract made, or to be made, between the applicant and
15 any person, corporation, partnership, or other entity for the performance on the
16 applicant's behalf of any functions including marketing, administration, enrollment,
17 investment management, and subcontracting for the provision of limited health
18 services to enrollees;
- 19 (13) A copy of the form of any group contract that is to be issued to employers, unions,
20 trustees, or other organizations and a copy of any form of evidence of coverage to be
21 issued to subscribers;
- 22 (14) A copy of the applicant's financial plan, including a three-year projection of
23 anticipated operating results, a statement of the sources of working capital, and any
24 other sources of funding and provisions for contingencies;

- 1 (15) A schedule of rates and charges;
- 2 (16) A description of the proposed method of marketing;
- 3 (17) A copy of the applicant's financial statements showing the applicant's assets,
4 liabilities, and sources of financial support, including a copy of the applicant's most
5 recent audited financial statement and an unaudited current financial statement, or if
6 the information is not applicable to the applicant, a list of the assets representing the
7 initial net worth of the applicant;
- 8 (18) A financial plan that provides a three-year projection of operating results, including:
 - 9 (a) A projection of balance sheets;
 - 10 (b) Income and expense statements anticipated from the start of operations until
11 the organization has had net income for at least one year;
 - 12 (c) Cash flow statements showing any capital expenditures, purchase and sale of
13 investments and deposits with the state;
 - 14 (d) Detailed enrollment projections;
 - 15 (e) The methodology for determining premium rates to be charged that has been
16 certified by a qualified actuary; and
 - 17 (f) A statement as to the sources of working capital as well as any other sources
18 of funding;
- 19 (19) The names and addresses of the applicants's qualified actuary and external auditors;
- 20 (20) If the applicant has a parent company and the director determines that additional
21 solvency guarantees are necessary, the parent company's guaranty, on a form
22 acceptable to the director, that the applicant will maintain the minimum net worth
23 required under this Act. If no parent company exists, a statement regarding the
24 availability of future funds, if needed;

- 1 (21) A description of the nature and extent of any reinsurance program to be implemented,
2 including a detailed risk retention schedule indicating direct, assumed, ceded, and net
3 maximum risk exposures on any one risk;
- 4 (22) A demonstration that errors and omission insurance or other arrangements
5 satisfactory to the director will be in place upon the applicant's receipt of a certificate
6 of authority;
- 7 (23) If the applicant is a foreign corporation, a statement from the appropriate regulatory
8 agency of the applicant's state of domicile stating that:
- 9 (a) The applicant is authorized to operate as a health maintenance organization in
10 the state of domicile;
- 11 (b) The regulatory agency has no objection to the applicant applying for a
12 certificate of authority in this state;
- 13 (24) The name and address of the applicant's statutory agent for service of process, notice,
14 or demand, or if not domiciled in this state, a power of attorney duly executed by the
15 applicant, appointing the director and duly authorized deputies, as the true and lawful
16 attorney of the applicant in and for this state upon whom all lawful process in any
17 legal action or proceeding against the health maintenance organization on a cause of
18 action arising in this state may be served;
- 19 (25) A description of the proposed policies, standards, and procedures for the management
20 of health information, including proposed policies, standards, and procedures that
21 guard against the unauthorized collection, use, or disclosure of protected health
22 information, that complies with §§ 58-2-40 and 58-2-41;
- 23 (26) A description of the proposed quality assessment and improvement activities
24 regarding the maintenance and improvement of the quality of health care services

1 provided to covered persons;

2 (27) A description of the proposed health care provider credentialing program;

3 (28) If the health maintenance organization will provide or perform utilization review
4 services, a description of the proposed utilization review procedures;

5 (29) A description of the proposed internal grievance procedures; and

6 (30) A description of the proposed external review procedures.

7 Section 4. That § 58-41-12 be amended to read as follows:

8 ~~58-41-12. Upon receipt of an application for issuance of a certificate of authority, the~~
9 ~~director shall forthwith transmit copies of such application and accompanying documents to the~~
10 ~~secretary.~~ The ~~secretary~~ director shall determine whether the applicant for a certificate of
11 authority has:

12 (1) Demonstrated the willingness and potential ability to assure that health care services
13 will be provided in a manner to assure both the availability and accessibility of
14 adequate personnel and facilities consistent with the requirements of chapter 58-17F;

15 (2) Arrangements, established in accordance with regulations promulgated by the
16 ~~secretary~~ director for an ongoing quality of health care assurance program consistent
17 with the requirements of chapter 58-17F, concerning health care processes and
18 outcomes;

19 (3) A procedure, established in accordance with ~~regulations~~ rules promulgated pursuant
20 to chapter 1-26 by the ~~secretary~~ director, to develop, compile, evaluate, and report
21 statistics relating to the cost of its operations, the pattern of utilization of its services,
22 the availability and accessibility of its services, and such other matters as may be
23 reasonably required by the ~~secretary~~ director; and

24 (4) Reasonable provisions for emergency and out-of-area health care services.

1 Section 5. That § 58-41-13 be amended to read as follows:

2 58-41-13. To the extent that it furthers the purposes of this chapter, the ~~secretary~~ director
3 shall attempt to coordinate the operations of this chapter relating to the quality of health care
4 services with the operations of 42 U.S.C. sections 1320c to 1320c-19.

5 Section 6. That § 58-41-15.1 be amended to read as follows:

6 58-41-15.1. Any ~~licensed~~ optometrist licensed pursuant to chapter 36-7, podiatrist licensed
7 pursuant to chapter 36-8, chiropractor licensed pursuant to chapter 36-5, psychologist licensed
8 pursuant to chapter 36-27A, or social worker licensed under § 36-26-17, may organize or
9 contract for services with a corporation organized under the laws of this state by licensed
10 practitioners of the healing arts, for the purpose of negotiating group health care contracts and
11 providing services within the scope of their respective licenses with alternate health care
12 delivery systems, including, ~~but not limited to~~, health maintenance organizations, preferred
13 provider organizations, individual practices organizations, or other similar ~~forms of entity~~
14 ~~whatever~~ entities.

15 Section 7. That § 58-41-16 be repealed.

16 ~~—58-41-16. Within thirty days of receipt of the application for issuance of a certificate of~~
17 ~~authority, the secretary shall certify to the director whether the proposed health maintenance~~
18 ~~organization meets the requirements of § 58-41-12. If the secretary certifies that the health~~
19 ~~maintenance organization does not meet such requirements, he shall specify in what respects~~
20 ~~it is deficient.~~

21 Section 8. That § 58-41-17 be amended to read as follows:

22 58-41-17. The director of the Division of Insurance shall issue or deny a certificate of
23 authority to any person filing an application pursuant to this chapter ~~within thirty days of receipt~~
24 ~~of the certification from the secretary of health~~. Issuance of a certificate of authority shall be

1 granted upon payment of the application fee prescribed in § 58-41-26 if the director is satisfied
2 that the following conditions are met:

3 (1) The persons responsible for the conduct of the affairs of the applicant are competent,
4 trustworthy, and possess good reputations;

5 (2) ~~The secretary certifies, in accordance with § 58-41-16, that the~~ health maintenance
6 organization's proposed plan of operation meets the requirements of § 58-41-12;

7 (3) The health maintenance contract constitutes an appropriate mechanism whereby the
8 health maintenance organization will effectively provide or arrange for the provision
9 of comprehensive health maintenance services on a prepaid basis, through insurance
10 or otherwise, except to the extent of reasonable requirements for copayments;

11 (4) The health maintenance organization is financially responsible and may reasonably
12 be expected to meet its obligations to enrollees and prospective enrollees;

13 (5) The health maintenance organization will assume full financial risk on a prospective
14 basis for the provision of comprehensive health maintenance services, including
15 hospital care;

16 (6) The enrollees will be afforded an opportunity to participate in matters of policy and
17 operation pursuant to §§ 58-41-23 and 58-41-24; and

18 (7) Nothing in the proposed method of operation, as shown by the information submitted
19 pursuant to §§ 58-41-4 to 58-41-10, inclusive, or by independent investigation, is
20 contrary to the public interest; ~~and~~

21 ~~(8) Any deficiencies certified by the secretary of the Department of Health have been~~
22 ~~corrected.~~

23 A certificate of authority ~~shall~~ may be denied only after compliance with the requirements
24 of §§ 58-41-87 to 58-41-90, inclusive.

1 Section 9. That § 58-41-24 be amended to read as follows:

2 58-41-24. The governing body shall establish a mechanism to afford the enrollees an
3 opportunity to express their opinions in matters of policy and operation through the
4 establishment of advisory panels, by the use of advisory referenda on major policy decisions,
5 or through the use of other mechanisms as may be prescribed or permitted by the ~~secretary~~
6 director.

7 Section 10. That § 58-41-26 be amended to read as follows:

8 58-41-26. Any health maintenance organization is exempt from all provisions of the
9 insurance laws of this state other than this chapter. However, the corporation is subject to the
10 provisions of this title on matters and procedures of mergers and licensure of insurance
11 producers. The corporation is also subject to fees and taxation as insurers under § 58-2-29 and
12 chapter 10-44. The corporation is also subject to §§ 58-17-53 and 58-17-54 if entering into a
13 contract after July 1, 1990, with the State of South Dakota, counties, school districts,
14 municipalities, and any other unit of state government using public funds. ~~For any individual~~
15 ~~health insurance contracts or policies, the health maintenance organization shall comply with~~
16 ~~the provisions of §§ 58-17-2 to 58-17-47, inclusive, 58-17-55 to 58-17-61, inclusive, 58-17-97,~~
17 ~~and 58-17-100 to 58-17-106, inclusive.~~ The state, however, may not collect premium taxes for
18 insurance written on individuals residing outside this state or property located outside this state
19 if no comparable tax is paid by the direct writing health maintenance organization to any
20 appropriate taxing authority. Health maintenance organizations are also subject to the following
21 chapters: 58-1, 58-2, 58-3, 58-4, 58-5, 58-6, 58-7, 58-11, 58-12, 58-14, 58-17, 58-17A, 58-17F,
22 58-17G, 58-17H, 58-17I, 58-18, 58-18A, 58-18B, 58-18C, 58-26, 58-27, 58-29B, 58-30, 58-
23 33A; and 58-43.

24 To the extent that a health maintenance organization is compliant with the provisions of

1 chapters 58-17F to 58-17I, inclusive, for purposes of network adequacy, quality assessment and
2 improvements, utilization review and benefit determinations, and grievance procedure, the
3 health maintenance organization is compliant with the provisions of this chapter.

4 Section 11. That § 58-41-45 be amended to read as follows:

5 58-41-45. No health maintenance organization or representative thereof may discriminate:

6 ~~—(1)—~~ ~~In~~ in the rates charged enrollees except in accordance with accepted actuarial
7 principles; ~~or~~

8 ~~—(2)—~~ ~~In~~ enrollment policy against any person solely by virtue of status as a recipient of
9 medical assistance or medicare.

10 Violation of this section is a Class 2 misdemeanor.

11 Section 12. That § 58-41-46 be repealed.

12 ~~—58-41-46. No schedule of charges for enrollee coverage for comprehensive health~~
13 ~~maintenance services, or amendment thereto, may be used in conjunction with any health~~
14 ~~maintenance contract until a copy of the schedule, or amendment thereto, has been filed with~~
15 ~~and approved by the director. No schedule of charges for an employer sponsored plan is subject~~
16 ~~to the provisions of this section.~~

17 Section 13. That § 58-41-47 be repealed.

18 ~~—58-41-47. The director shall, within a reasonable period, approve any form if the~~
19 ~~requirements of § 58-41-43 are met and any schedule of charges if the requirements of § 58-41-~~
20 ~~44 are met. No person may issue a form or use a schedule of charges, except those not subject~~
21 ~~to § 58-41-46, until approved. If the director does not disapprove any form or schedule of~~
22 ~~charges within thirty days of the filing of the forms or schedules, they shall be deemed~~
23 ~~approved.~~

24 Section 14. That § 58-41-48 be repealed.

1 ~~58-41-48. If the director disapproves such filing, he shall notify the filer. In the notice, the~~
2 ~~director shall specify the reasons for his disapproval. A hearing will be granted within twenty~~
3 ~~days after a request in writing by the person filing.~~

4 Section 15. That § 58-41-49 be repealed.

5 ~~58-41-49. The director may require the submission of whatever relevant information he~~

20 Section 17. That § 58-41-63 be amended to read as follows:

21 58-41-63. Every health maintenance organization shall annually, on or before March first,
22 file a report verified by at least two principal officers with the director, ~~with a copy to the~~
23 ~~secretary~~ covering the preceding calendar year. Such report shall be on forms prescribed by the
24 director and shall include:

- 1 (1) A financial statement of the organization, including its balance sheet and receipts and
2 disbursements for the preceding year certified by an independent certified public
3 accountant, reflecting at least:
 - 4 (a) Prepayment and other payments received for health care services rendered;
 - 5 (b) Expenditures to all providers, by classes or groups of providers, and insurance
6 companies or nonprofit health service plan corporations engaged to fulfill
7 obligations arising out of the health maintenance contract; and
 - 8 (c) Expenditures for capital improvements, or additions thereto, including but not
9 limited to construction, renovation or purchase of facilities and capital
10 equipment;
- 11 (2) Any material changes in the information submitted pursuant to §§ 58-41-6 to 58-41-

- 13 (3) The number of new enrollees enrolled during the year, the number of enrollees as of
14 the end of the year and the number of enrollees terminated during the year;
- 15 (4) A summary of information compiled pursuant to subdivision 58-41-12(3) on such
16 form as may be required by the ~~secretary~~ director;
- 17 (5) A report of the names and residence addresses of all persons set forth in subdivision
18 58-41-6(3), who were associated with the health maintenance organization during the
19 preceding year, and the amount of wages, expense reimbursements, or other
20 payments to such individuals for services to the health maintenance organization,
21 including a full disclosure of all financial arrangements during the preceding year
22 required to be disclosed pursuant to subdivision 58-41-6(3); and
- 23 (6) Such other information relating to the performance of the health maintenance
24 organization as is reasonably necessary to enable the director to carry out his duties

1 under this chapter.

2 Section 18. That § 58-41-65 be amended to read as follows:

3 58-41-65. All applications, filings, and reports required under this chapter ~~shall be treated~~
4 ~~as~~ are public documents except as provided for by § 1-27-30.

5 Section 19. That § 58-41-67 be amended to read as follows:

6 58-41-67. The director ~~and secretary~~ may, pursuant to chapter 1-26, promulgate such
7 reasonable rules as are necessary to carry out the provisions of this chapter. Included among
8 such rules shall be those which provide minimum requirements for the provision of
9 comprehensive health maintenance services, as defined in subdivision 58-41-1(1), and
10 reasonable exclusions therefrom.

17 ~~as often as the director deems necessary for the protection of the interests of the people of this~~
18 ~~state, but not less frequently than once every five years pursuant to chapter 58-3.~~

19 Section 22. That § 58-41-70 be repealed.

20 ~~— 58-41-70. The secretary may make an examination concerning the quality of health care~~
21 ~~services provided to enrollees by any health maintenance organization and providers with whom~~
22 ~~such organization has contracts, agreements, or other arrangements pursuant to its health care~~
23 ~~plan as often as the secretary deems necessary for the protection of the interests of the people~~
24 ~~of this state, but not less frequently than once every three years, provided, that examinations of~~

1 ~~providers pursuant to this section shall be limited to their dealing with the health maintenance~~
2 ~~organization and its enrollees.~~

3 Section 23. That § 58-41-71 be repealed.

4 ~~— 58-41-71. In order to accomplish the duties described in §§ 58-41-68 to 58-41-70, inclusive,~~
5 ~~the director and the secretary shall have the rights respectively to:~~

6 ~~— (1) — Audit and inspect any books and records of a health maintenance organization which~~
7 ~~pertain to services performed and determinations of amounts payable under such~~
8 ~~contract; and~~

9 ~~— (2) — Inspect or otherwise evaluate the quality, appropriateness, and timeliness of services~~
10 ~~performed under such contract.~~

11 Section 24. That § 58-41-72 be repealed.

12 ~~— 58-41-72. For the purpose of examinations, the director and the secretary may administer~~
13 ~~oaths to and examine the officers and insurance producers of the health maintenance~~
14 ~~organization and the principals of such providers concerning their business, and to issue~~
15 ~~subpoenas.~~

16 Section 25. That § 58-41-75 be repealed.

17 ~~— 58-41-75. Reasonable expenses of examinations under §§ 58-41-68 to 58-41-72, inclusive,~~
18 ~~shall be assessed against the organization being examined, and shall be remitted to the director~~
19 ~~or secretary.~~

20 Section 26. That § 58-41-76 be repealed.

21 ~~— 58-41-76. In lieu of examination under §§ 58-41-68 to 58-41-72, inclusive, the director or~~
22 ~~secretary may accept the report of an examination made by the director or secretary of another~~
23 ~~state.~~

24 Section 27. That § 58-41-81 be amended to read as follows:

1 58-41-81. The director may suspend or revoke any certificate of authority issued to a health
2 maintenance organization under this chapter if the director finds that any of the following
3 conditions exists:

4 (1) The health maintenance organization is operating significantly in contravention of
5 its basic organizational document, its health maintenance contract, or in a manner
6 contrary to that described in and reasonably inferred from any other information
7 submitted under this chapter, unless amendments to such submissions have been filed
8 with and approved by the director;

9 (2) The health maintenance organization issues evidence of coverage or uses a schedule
10 or charges for health care services which do not comply with the requirements of
11 §§ 58-41-34 to ~~58-41-49~~ 58-41-45, inclusive;

12 (3) The health care plan does not provide or arrange for comprehensive health
13 maintenance services;

14 (4) The health maintenance organization is no longer financially responsible and may
15 reasonably be expected to be unable to meet its obligations to enrollees or
16 prospective enrollees;

17 (5) The health maintenance organization has failed to implement a mechanism affording
18 the enrollees an opportunity to participate in matters of policy and operation under
19 the provisions of §§ 58-41-23 and 58-41-24;

20 (6) The health maintenance organization has failed to implement the complaint system
21 in a manner designed to reasonably resolve valid complaints;

22 (7) The health maintenance organization, or any person acting with its sanction, has
23 advertised or merchandised its services in an untrue, misrepresentative, misleading,
24 deceptive, or unfair manner;

1 (8) The continued operation of the health maintenance organization would be hazardous
2 to its enrollees; or

3 (9) The health maintenance organization has otherwise failed to substantially comply
4 with this chapter, has violated a provision of chapter 58-33 or any other provision of
