- 1 An Act to grant immunity from certain liabilities for camping activities.
- 2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:
- 3 Section 1. That chapter 34-18 be amended with a NEW SECTION:

5	<u>(1)</u>	"Camping," visiting, staying at, using, and leaving a private campground, including	
6		<u>lodging</u>	of all types;
7	<u>(2)</u>	"Inherent risks of camping," dangers and hazards from:	
8		<u>(a)</u> F	Features of the natural world, such as trees, tree stumps, naturally
9		<u>C</u>	occurring infectious agents, roots, brush, rocks, mud, sand, standing and

5		(I) Fireworks of a camper, visitor, or offsite entity not authorized by the private		
6		campground owner or employee or officer of a private campground owner;		
7		<u>and</u>		
8		(m) Any person coming onto the campsite not reported to the private		
9		campground owner or an employee or officer of the private campground		
10		<u>owner.</u>		
11	<u>(3)</u>	"Private campground," any parcel or tract of land, including buildings and other		
12		structures, that is owned or operated by a private property owner where five or		
13		more campsites are made available for use as temporary living quarters for		
14		recreational, camping, travel, or seasonal use. The term also includes recreational		
15		vehicle parks.		
16	Section 2	2. That chapter 34-18 be amended with a NEW SECTION:		
17		Except as provided under section 3 of this Act, a private campground owner, or an		
18	emplo	oyee or officer of a private campground owner, is not liable if a person is injured or		
19	•	killed or property is damaged as a result of an inherent risk of camping.

20	Section 3	3. That chapter 34-18 be amended with a NEW SECTION:		
2.1				
21		The provisions of section 2 of this Act do not limit the liability of a private		
22		ground owner or an employee or officer of a private campground owner who:		
23	<u>(1)</u>	Intentionally causes the injury, death, or property damage;		
24	<u>(2)</u>	Acts with a willful or wanton disregard for the safety of the person or property		
25		damaged. This includes conduct committed with an intentional or reckless		
26		disregard for the safety of others;		
27	<u>(3)</u>	Fails to use that degree of care that an ordinarily careful and prudent person would		
28		use under the same or similar circumstances; or		
29	<u>(4)</u>	Fails to conspicuously post warning signs of a dangerous, inconspicuous condition		
30		known to the owner of the private campground, or his or her employees or officers,		
31		on the property that the owner owns, leases, rents, or is otherwise in lawful control		
32		of or in possession of, if the owner, employee, or officer is aware of the condition		
33		by reason of a prior injury involving the same location or the same mechanism of		

injury. Such warning signs must appear in black letters on a white background with
each letter a minimum of one inch in height.

Section 4. That chapter 34-18 be amended with a NEW SECTION:

Every written contract entered into by a private campground owner or an employee				
or officer of a private campground owner must contain, in clearly readable print, the				
warning notice specified in this section. A warning sign must be posted at the entrance or				
registration desk of a private campground. The signs described in section 3, subdivision				
(4) of this Act and contracts described in this section must contain the following warning				
<u>WARNING</u>				
Under South Dakota law, a private campground owner or an employee or officer of				
a private campground owner is not liable for an injury to or the death of a person or any				
property damage resulting from the inherent risks of camping.
