Report Title: Anna Johnson Interview

Details:

(ALL TIMES ARE APPROXIMATE)

- 1. On September 14, 2020, at approximately 6:30 p.m., Special Agent (S/A) Joe Arenz and Supervisory Special Agent (SS/A) Arnie Rummel spoke to Anna Johnson outside of the Highmore Manor apartment complex. Anna Johnson had just arrived in a vehicle with Jennifer Boever. Jennifer Boever remained present during the interview.
- Anna Johnson stated the following regarding Anna Johnson's contact with Joseph Boever on Highway 14 on September 12, 2020:
 - Anna Johnson saw Joseph Boever walking on the shoulder of Highway 14.
 - B. Anna Johnson initially went past Joseph Boever as Joseph Boever walked along Highway 14 and then Anna Johnson turned around at the approach leading to Sheriff Mike Volek's residence and went back to Joseph Boever.
 - C. Anna Johnson asked Joseph Boever if Joseph Boever needed help. Joseph Boever told Anna Johnson that Joseph Boever was looking for Joseph Boever's pickup.
 - D. Anna Johnson asked Joseph Boever if Joseph Boever was intoxicated because Joseph Boever was stumbling. Joseph Boever told Anna Johnson that Joseph Boever was not intoxicated.
 - E. Anna Johnson thought Joseph Boever was walking on the dirt on the shoulder of the road.
 - F. Anna Johnson saw Joseph Boever between 10:15 p.m., and 10:20 p.m.
 - G. Joseph Boever was walking westbound when Anna Johnson saw Joseph Boever.
 - H. Anna Johnson recognized Joseph Boever when Anna Johnson spoke to Joseph Boever, but she did not realize it was Joseph Boever until Anna Johnson pulled up next to Joseph Boever.
 - Joseph Boever was wearing glasses at the time when Anna Johnson spoke to Joseph Boever. Joseph Boever was not wearing anything on Joseph Boever's head.
 - J. Joseph Boever was using Joseph Boever's phone light. When Joseph Boever walked up to the van, Joseph Boever was still looking in the ditch using the light.

- 3. Jennifer Boever said Joseph Boever wore a brown plastic framed pair of eyeglasses when Joseph Boever read.
- Jennifer Boever said that Joseph Boever took a cell phone with Joseph Boever when Joseph Boever would leave the house.
- 5. Jennifer Boever asked why Jennifer Boever was not notified about Joseph Boever's death until approximately 11:00 a.m., on September 14, 2020. SS/A Rummel explained Joseph Boever's cousins did not provide any information regarding Jennifer Boever being Joseph Boever's wife.
