- 1. On September 24, 2020, at approximately 3:37 pm, Special Agent (S/A) Joe Arenz spoke over the phone to Shalon Arenholz. S/A Arenz had previously been advised that Shalon Arenholz had approached a South Dakota Highway Patrol (SDHP) Trooper on September 13, 2020, and spoke to the trooper about Joseph Boever.
- 2. Shalon Arenholz stated the following:
  - A. Shalon Arenholz lived next door to Joseph Boever.
  - B. On September 13, 2020, Shalon Arenholz arrived home from a weekend camping trip and Victor Nemic was at Joseph Boever's residence.
  - C. Victor Nemic asked Shalon Arenholz if Shalon Arenholz knew the whereabouts of Joseph Boever because Victor Nemic could not find Joseph Boever.
  - D. Shalon Arenholz did not know where Joseph Boever was.
  - E. Shalon Arenholz and Joseph Boever would check in on each other frequently.
  - F. Approximately 1½ months ago, Joseph Boever nearly drank himself to death until Shalon Arenholz intervened.
  - G. Joseph Boever was on medications for bipolar disorder, alcohol, attention deficit hyperactivity disorder (ADHD), and insulin for diabetes.
