**Report Title: Richard Ravensborg Interview**

**Details:**

(ALL TIMES ARE APPROXIMATE)

1. On September 29, 2020, at approximately 9:07 p.m., Special Agent (S/A) Joe Arenz and Supervisory Special Agent (SS/A) Arnie Rummel spoke over the phone to JASON RAVNBORG's father, Richard Ravensborg. S/A Arenz explained the North Dakota Bureau of Criminal Investigation (NDBCI) was investigating the car crash that occurred involving JASON RAVNSBORG.
2. S/A Arenz explained JASON RAVNSBORG had stated JASON RAVNSBORG spoke to Richard Ravensborg over the phone while JASON RAVNSBORG was driving home from Redfield, South Dakota, prior to the crash. JASON RAVNSBORG also called Richard Ravensborg after the crash. Richard Ravensborg confirmed the phone calls.
3. Richard Ravensborg thought the call after the crash was between 10:15 p.m., and 10:30 p.m.
4. Richard Ravensborg stated Richard Ravensborg and JASON RAVNSBORG's call after the crash consisted of the following conversation:
  - A. JASON RAVNSBORG said JASON RAVNSBORG hit something with JASON RAVNSBORG's vehicle and JASON RAVNSBORG thought it was possibly a deer.
  - B. JASON RAVNSBORG did not see anything and did not see a deer, but JASON RAVNSBORG assumed it was a deer because of where JASON RAVNSBORG was in the country.
  - C. JASON RAVNSBORG said the car was damaged on the right front corner and the windshield was broke. JASON RAVNSBORG sent Richard Ravensborg a photo of the damage on September 13, 2020.
  - D. JASON RAVNSBORG said JASON RAVNSBORG called 911 and the sheriff came out.
  - E. JASON RAVNSBORG and the sheriff looked around together to see what JASON RAVNSBORG hit. JASON RAVNSBORG only had a cell phone light to use to look around.
  - F. JASON RAVNSBORG did not say anything to Richard Ravensborg about being tired, and JASON RAVNSBORG did not sound tired while talking to Richard Ravensborg.

- G. JASON RAVNSBORG told Richard Ravensborg that JASON RAVNSBORG only drank one "Coca Cola" at the Lincoln Day Dinner in Redfield. Richard Ravensborg said that JASON RAVNSBORG was not a drinker.
  - H. JASON RAVNSBORG told Richard Ravensborg that JASON RAVNSBORG was not using JASON RAVNSBORG's cell phone at the time of the crash nor was JASON RAVNSBORG speeding or driving off on the shoulder of the road.
