1 **An Act to update provisions related to the licensure of funeral directors and the**
 2 **provision of funeral services.**

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 **Section 1. That § 36-19-1 be AMENDED:**

5 **36-19-1.** Terms used in this chapter mean:

- 6 (1) "Board," the State Board of Funeral Service;
- 7 ~~(1A)~~(2) "Branch chapel," a separate facility with a visitation room or chapel ~~where, in~~
 8 which no embalming is permitted ~~that, and which~~ is owned by, a subsidiary of, or
 9 otherwise financially connected to or controlled by a licensed funeral
 10 establishment;
- 11 ~~(2)~~ "Embalmer," any person engaged in or conducting, or holding the person out as
 12 engaged in or conducting, the business of disinfecting, preserving, or both, or
 13 attempting to disinfect or preserve, or both, or cremate, dead human bodies, in
 14 whole or in part by use of chemicals externally, internally or by other methods, as
 15 approved by the department of health;
- 16 (3) "Funeral director," any person, ~~partnership, limited liability company, corporation,~~
 17 ~~association, or organization~~ engaged in or conducting or holding that person out as
 18 being engaged in or conducting, at a funeral establishment, the business of
 19 preparing, other than embalming, for burial or disposal, and supervising the burial
 20 or disposal of dead human bodies, or who shall, in connection with the person's
 21 name or business, use the title, funeral director, undertaker, mortician, or any
 22 other title implying that the person is engaged in the business herein described:
- 23 (a) Conducting funeral services and burials of casketed remains;
- 24 (b) Disinfecting and preserving dead human bodies; or
- 25 (c) Cremating human remains;

- 1 (4) "Funeral establishment," ~~any place of a business conducted,~~ at a specific street
 2 ~~address or physical~~ location, ~~devoted to the care and preparation~~ carrying for and
 3 preparing dead human bodies for burial or transportation ~~of dead human bodies;~~
- 4 (5) "Funeral service," ~~those service provided or rendered by an embalmer or funeral~~
 5 ~~director, or both, as set forth in subdivisions (2) or (3) of this section;~~
- 6 (6) "Trainee in funeral service," any person who has registered with the board and is
 7 engaged in the training of to provide funeral service. ~~However, no person may~~
 8 ~~serve or attempt to serve as such trainee until that person has filed a registration~~
 9 ~~with the board of funeral service as set forth in this chapters~~ services.

10 **Section 2. That § 36-19-2 be AMENDED:**

11 **36-19-2.** ~~The State Board of Funeral Service shall include the five~~
 12 ~~professional~~ consists of five members who shall appointed by the Governor.

13 Four members must be persons who have been licensed to practice funeral
 14 ~~service. The Governor shall appoint the professional members of the board. However, no~~
 15 ~~person may be appointed as a professional member of the board who has not been~~
 16 ~~licensed in this state, as an embalmer and funeral director, or to practice funeral service,~~
 17 ~~for at least five years prior to appointment~~ for at least five years and are currently licensed
 18 in accordance with this chapter. One member must be a representative of the public who
 19 is not associated with or financially interested in the provision of funeral services and is
 20 not a member of a related profession or a practitioner of a related occupation.

21 ~~The term of office of appointed members is three years. The~~ In the event of a
 22 vacancy, the Governor shall, by appointment, fill any vacancy.

23 ~~The board shall also include two lay members who are users of the services~~
 24 ~~regulated by the board. The term, lay member who is a user, refers to a person who is~~
 25 ~~not licensed by the board but, where practical, uses the service licensed. The term shall~~
 26 ~~be liberally construed to implement the purpose of this section. The Governor shall appoint~~
 27 ~~the lay members. The lay members shall have the same term of office as other members~~
 28 ~~of the board~~ appoint a new member to fill the unexpired term.

29 ~~No~~ A board member may not serve more than three consecutive full terms.
 30 ~~However,~~ An appointment to fill an unexpired term is not considered a complete to be a full
 31 ~~term for this purpose. The Governor may stagger the terms to enable the board to have~~
 32 ~~different terms expire each year.~~

33 ~~The terms of members begin~~ Each term of office begins on October thirty-first ~~of~~
 34 ~~the calendar year in which the Governor appoints the member, unless otherwise~~

1 designated by the Governor. The appointee's term expires on October thirtieth in the third
2 year of appointment.

3 ~~Any member's term ending June 30, 2013, or thereafter is extended to October~~
4 ~~thirtieth in the year the term is to expire.~~

5 ~~The board shall also include the secretary of health or the secretary's designee~~
6 ~~shall serve as a-an ex officio, nonvoting member of the board.~~

7 **Section 3. That § 36-19-6 be AMENDED:**

8 ~~36-19-6. The State Board of Funeral Service~~board shall meet at least ~~once a~~ twice
9 each year, at a time and place established by the board, and may also hold
10 special~~additional~~ meetings as frequently as the proper and efficient discharge of its duties
11 requires.

12 ~~Four members constitute a quorum for the transaction of business~~at the call of the
13 president or at the request of a majority of the board.

14 **Section 4. That § 36-19-6.1 be AMENDED:**

15 ~~36-19-6.1. The State Board of Funeral Service~~ board shall continue within the
16 Department of Health, and shall retain all its prescribed functions, including administrative
17 functions. The board shall submit such records, information, and reports in the form and
18 at such times as required by the secretary of health, ~~except that the board shall report at~~
19 ~~least annually.~~

20 **Section 5. That § 36-19-7 be AMENDED:**

21 ~~36-19-7. The State Board of Funeral Service may, pursuant to chapter 3-6D,~~
22 ~~determine the compensation of the secretary and other assistants as may be necessary~~
23 ~~to carry out the provisions of this chapter and any rules promulgated under this chapter.~~
24 ~~The board may incur other expenses as may be necessary. The compensation of the~~
25 ~~members and the other expenses of the board shall be paid out of the fees received from~~
26 ~~applicants and licensees~~Each member of the board shall receive per diem compensation
27 in accordance with § 4-7-10.4 and reimbursement for expenses incurred while engaged
28 in official business, as provided by law.

29 **Section 6. That § 36-19-9 be AMENDED:**

1 ~~36-19-9.~~ The State Board of Funeral Service may elect, out of its own
 2 numberboard shall annually elect, from among its own members, a president, a
 3 vice-president, and ~~secretary treasurer, and,~~ pursuant to chapter 1-26, promulgate the
 4 rules ~~as may be reasonable and proper to:~~

5 (1) ~~Establish the minimum physical standards of licensees' funeral establishments;~~

6 (2) ~~Regulate the inspection of each funeral establishment;~~

7 (3) ~~Establish the educational, training, reciprocity and renewal requirements for~~
 8 ~~licensure; and~~

9 (4) ~~However, the board may not regulate the method and manner of providing funeral~~
 10 ~~service.~~

11 ~~The treasurer of the board shall give bond in the sum of five thousand dollars with~~
 12 ~~sufficient sureties to be approved by the board, conditioned for the honest and faithful~~
 13 ~~discharge of the treasurer's duties~~ a secretary.

14 **Section 7. That § 36-19-12 be AMENDED:**

15 ~~36-19-12.~~ It shall be the duty of the State Board of Funeral Service to examine
 16 applicants for licenses as provided by this chapter; to keep all necessary records; receive
 17 registrations of trainees in funeral service; to control and issue reciprocal licenses and
 18 renewals of all other licenses as provided in this chapter; to revoke or suspend upon
 19 proper cause, and to provide hearings in such matters and to investigate any and all
 20 complaints originating from the violation of any section or sections of this chapterThe
 21 board may:

22 (1) Issue and renew licenses, as provided in this chapter;

23 (2) Issue subpoenas, examine witnesses, administer oaths, conduct hearings and, at
 24 its discretion, investigate allegations of violations of this chapter, and impose
 25 penalties for such violations;

26 (3) Enter into contracts and employ necessary personnel to carry out its responsibilities
 27 under this chapter;

28 (4) Communicate disciplinary actions to state and federal authorities and to other state
 29 funeral director licensing authorities; and

30 (5) Perform other duties as necessary to administer this chapter.

31 **Section 8. That chapter 36-19 be amended with a NEW SECTION:**

32 The board shall promulgate rules, in accordance with chapter 1-26, to:

33 (1) Administer, coordinate, and enforce this chapter;

- 1 (2) Establish requirements for license application and renewal;
 2 (3) Establish standards of professional conduct;
 3 (4) Establish standards for the operation of a funeral establishment; and
 4 (5) Establish fees for licensure application and licensure renewal, as provided for in §§
 5 36-19-25 and 36-19-27.

6 **Section 9. That § 36-19-14 be AMENDED:**

7 **36-19-14.** ~~No~~ A person shall embalm ~~may not, without being licensed by the~~
 8 board:

- 9 (1) Embalm any dead human body ~~or practice;~~
 10 (2) Practice embalming, ~~or direct;~~
 11 (3) Direct or supervise funerals, ~~practice;~~
 12 (4) Practice funeral service, ~~; or maintain~~
 13 (5) Maintain a funeral establishment in the State of South Dakota, ~~without being~~
 14 licensed by the State Board of Funeral Service ~~this state.~~

15 **Section 10. That § 36-19-18 be AMENDED:**

16 **36-19-18.** ~~The State Board of Funeral Service~~ board ~~shall provide for the~~
 17 ~~registration of trainees for licensure~~ each trainee pursuing licensure ~~to practice funeral~~
 18 ~~service. Trainees shall at all times remain registered with the board and~~ The board
 19 ~~shall pay an initial, by rule promulgated in accordance with chapter 1-26, provide for a~~
 20 ~~registration fee, which may not to exceed twenty-five dollars set by the State Board of~~
 21 ~~Funeral Service, by rule promulgated pursuant to chapter 1-26.~~

22 **Section 11. That § 36-19-21 be AMENDED:**

23 **36-19-21.** ~~In order to obtain a license in the practice of funeral service, the~~
 24 ~~applicant shall submit evidence that the applicant is a citizen of the United States or a~~
 25 ~~resident of South Dakota; is~~ The board may issue a license to practice funeral service to
 26 any person who:

- 27 (1) Is ~~at least eighteen years of age; is of good moral character; has sixty semester~~
 28 ~~hours credit from a college or university in a course approved by the State Board~~
 29 ~~of Funeral Service; has completed one year's course at a school of embalming,~~
 30 ~~accredited by the board; has completed one year's work as a trainee~~
 31 ~~embalmer funeral director in this state; and has passed an examination on the~~

1 following subjects: ~~embalming and care, disposition and preservation of the bodies~~
 2 ~~of deceased persons, sanitation for the prevention of the spread of infectious or~~
 3 ~~contagious diseases, and local health and sanitation ordinances and regulations~~
 4 ~~relating to mortuary science~~

5 (2) Submits an application on a form prescribed by the board;

6 (3) Pays the application fee established by the board, in accordance with section 8 of
 7 this Act;

8 (4) Has completed at least ninety credit hours offered by an accredited institution of
 9 higher education and obtained a degree or a certificate from a mortuary science or
 10 funeral service program that is accredited by the American Board of Funeral Service
 11 Education;

12 (5) Has completed one year as a trainee under a person licensed pursuant to this
 13 chapter;

14 (6) Has passed the national board examination, administered by the International
 15 Conference of Funeral Service Examining Board; and

16 (7) Has not committed any act that constitutes a ground for denying, suspending, or
 17 revoking a license under this chapter.

18 **Section 12. That § 36-19-25 be AMENDED:**

19 **36-19-25.** A license to practice funeral service ~~shall be issued and is~~
 20 ~~renewable~~must be renewed annually ~~upon payment of a~~. The board shall, by rule
 21 promulgated in accordance with chapter 1-26, establish the renewal fee, which may not
 22 ~~to exceed one hundred twenty-five dollars set by the State Board of Funeral Service, by~~
 23 ~~rule promulgated pursuant to chapter 1-26.~~

24 **Section 13. That § 36-19-27 be AMENDED:**

25 **36-19-27.** An application for a license to operate a funeral establishment ~~shall be~~
 26 ~~submitted~~is required for each location ~~and shall be in writing~~. The application must be on
 27 a form provided by the State Board of Funeral Service and shall be accompanied by a fee
 28 ~~not to exceed two hundred fifty dollars set by the State Board of Funeral Service, by rule~~
 29 ~~promulgated pursuant to chapter 1-26. A license to operate a funeral establishment may~~
 30 ~~be granted upon approval and recommendation by the stateboard~~ and accompanied by
 31 an application fee.

32 The board shall, by rule promulgated in accordance with chapter 1-26, establish
 33 the application fee, which may not exceed two hundred fifty dollars.

1 The board may inspect the funeral establishment to verify compliance with state
2 law and rules of the board.

3 The application ~~shall state~~for a license to operate a funeral establishment must
4 include the name of the individual who is ~~duly licensed as either a funeral director or in~~
5 ~~funeral service~~under this chapter and ~~who shall be in charge and responsible for~~ managing
6 all transactions conducted and services performed.

7 **Section 14. That § 36-19-30 be AMENDED:**

8 **36-19-30.** ~~Every~~Each funeral establishment ~~shall~~must be managed ~~and~~
9 conducted by a person licensed to practice funeral service, ~~or who is a licensed funeral~~
10 ~~director~~ under this chapter.

11 **Section 15. That § 36-19-31 be AMENDED:**

12 **36-19-31.** ~~Each~~The board shall inspect each funeral establishment ~~shall be~~
13 ~~inspected annually by a member of the State Board of Funeral Service, or by an inspector~~
14 ~~employed by said board~~at least once every three years.

15 **Section 16. That § 36-19-32 be AMENDED:**

16 **36-19-32.** The holder of any funeral establishment license who transfers the
17 location of ~~such the~~ establishment, ~~or~~ ceases to operate the ~~same~~establishment, or
18 transfers ~~such the~~ license to another, shall, within five days thereafter, notify the ~~State~~
19 ~~Board of Funeral Service~~ thereof. ~~In case of transfer of such license~~board. If the location
20 is transferred, the transferee shall ~~promptly furnish~~provide to the board the name of the
21 individual who is ~~duly licensed as either a funeral director or in funeral service,~~ and who
22 ~~will, and shall, be in charge and,~~ in accordance with this chapter, and is responsible for all
23 transactions conducted and services performed ~~therein.~~

24 The board may inspect the new location to verify compliance with state law and
25 rules of the board.

26 **Section 17. That § 36-19-36 be AMENDED:**

27 **36-19-36.** ~~Every~~Each license issued under this chapter, ~~except other than the~~
28 funeral establishment license, ~~shall be nontransferable~~is not transferable and ~~shall~~must
29 be displayed by ~~such the~~ licensee in a conspicuous place in ~~his or her~~the licensee's office
30 or place of business.

1 **Section 18. That § 36-19-37 be AMENDED:**

2 ~~36-19-37. All licenses~~Each license issued under the provisions of this chapter are
3 ~~valid only until expires on the following December thirty-first day of December.~~

4 ~~If a licensee desires a renewal of such license, the State Board of Funeral Service~~
5 ~~shall grant it, except for cause in compliance with chapter 1-26. All applications.~~

6 ~~Each application for renewal shall must be made within thirty days prior to the~~
7 ~~expiration of the license and shall submitted to the board during the month of December~~
8 ~~and must be accompanied by a renewal fee. The board shall promulgate rules, in~~
9 ~~accordance with chapter 1-26, to establish the amount of the fee, which may not to exceed~~
10 ~~two hundred fifty dollars, set by the board, by rule promulgated pursuant to chapter 1-~~

15 ~~license holder or the license applicant:~~

16 (1) ~~Obtained the license by fraud or misrepresentation either in applying for the license~~
17 ~~or in passing the examination for the license;~~

18 (2) ~~Alters a license;~~

19 (3) ~~Uses intoxicants or drugs to such a degree as to render the person unfit to practice~~
20 ~~funeral service or funeral directing;~~

21 (3)(4) ~~Has been convicted of a:~~

22 (a) ~~A felony;~~ or

23 (b) ~~Any crime involving moral turpitude. However, upon the conviction of a~~
24 ~~holder of a valid license, of a felony or crime involving moral turpitude, the~~
25 ~~conviction shall immediately and automatically revoke the license;~~

26 (4) ~~Is not a person of good moral character~~ dishonesty, any conduct intended to
27 deceive or defraud the public, or any other unprofessional conduct;

28 (5) ~~Is guilty of malpractice in the business of funeral service or funeral directing;~~

29 (6) ~~Is guilty of willful violation of any section of~~ willfully violating this chapter, ~~or any~~
30 ~~rule of the board, or any rule of the state or any municipal board or department of~~
31 ~~health ordinance or federal regulation governing the disposition, shipment, or~~
32 ~~transportation of dead human bodies; or willfully fails to make any report required~~
33 ~~by law or by the rules of the board;~~

- 1 (7) Signs a certificate stating that the person embalmed or prepared a dead human
 2 body for shipment or burial, ~~whereas if in fact, someone, other than the another~~
 3 ~~person signing the certificate,~~ other than a trainee for whom supervision was
 4 provided, embalmed or prepared the dead human body for shipment or burial;
- 5 (8) ~~Pays or~~ Directly or indirectly:
- 6 (a) ~~Pays or~~ causes to be paid, directly or indirectly, a commission for the
 7 securing of business; or, ~~directly or indirectly solicits such~~
- 8 (b) Solicits business. However, provided that the soliciting of members or the
 9 selling of stock in any cooperative burial association is not a violation of this
 10 subdivision;
- 11 (9) Engages in any practice or conduct that constitutes a danger to the health, safety,
 12 or welfare of the public;
- 13 (10) Engages in any conduct that is unbecoming of a licensee or applicant;
- 14 (11) Has been disciplined by the board of another state or territory for any act or
 15 omission that would be a violation of this chapter or rules adopted by the board;
- 16 (11) Fails to report to the board:
- 17 (a) Any discipline imposed by the board of another state or territory;
- 18 (b) Any felony conviction; or
- 19 (c) Any conviction for an offense arising out of the practice of funeral service;
- 20 (12) Has employed, enabled, or assisted the unlicensed practice or provision of any
 21 service, other than that authorized by this chapter or rules adopted by the board;
- 22 (13) Fails to maintain adequate safety and sanitary conditions or other requirements of
 23 funeral establishments, as set forth in this chapter or rules adopted by the board
 24 pursuant to chapter 1-26; or
- 25 (14) Engages in any unfair or deceptive act or practice.

26 If the license as funeral director is held by a firm, corporation, association, or
 27 organization, the provisions of this section apply to the members of the board of directors,
 28 officers, and employees, as well as to the firm, corporation, association, or organization.

29 **Section 20. That § 36-19-3 be REPEALED:**

30 ~~For the purpose of this chapter this state is hereby divided into five districts, and~~
 31 ~~one professional member of the State Board of Funeral Service shall be appointed as~~
 32 ~~provided in § 36-19-2 from each of the said districts. The first district shall consist of the~~
 33 ~~following counties: Moody, Lake, the portion of McCook east of state highway 81,~~
 34 ~~Minnehaha, Silver Lake, Grandview, Valley and Molan townships in Hutchinson, Turner,~~

14 ~~officers, which shall be filed in the Office of the Secretary of State.~~

15 **Section 22. That § 36-19-5 be REPEALED:**

16 ~~The Governor may remove an appointive member of the State Board of Funeral~~
17 ~~Service for cause, and a member appointed to fill such vacancy caused by death,~~
18 ~~resignation, or removal shall serve during the unexpired term of his predecessor.~~

19 **Section 23. That § 36-19-10 be REPEALED:**

20 ~~The State Board of Funeral Service shall be authorized to adopt and use a common~~
21 ~~seal.~~

22 **Section 24. That § 36-19-13 be REPEALED:**

23 ~~No person shall be employed as an inspector by the State Board of Funeral Service~~
24 ~~unless such person has been licensed in this state as an embalmer and funeral director,~~
25 ~~and has practiced funeral service, for at least five years prior to his appointment.~~

26 **Section 25. That § 36-19-17 be REPEALED:**

27 ~~Every funeral director who, on July 1, 1963, held a license which had been duly~~
28 ~~issued under the laws of this state, is entitled to have his license renewed annually upon~~

1 ~~payment of renewal fees of not to exceed fifty dollars set by the State Board of Funeral~~
2 ~~Service, by rule promulgated pursuant to chapter 1-26.~~

3 **Section 26. That § 36-19-20 be REPEALED:**

4 ~~Any person desiring to obtain a license to practice funeral service under this chapter~~
5 ~~shall make application to the State Board of Funeral Service. The application shall contain~~
6 ~~such information as the board may require and be upon a form prepared by the board.~~
7 ~~Upon receipt of the application, the board shall fix a date and place for the examination~~
8 ~~of the applicant of which notice shall be given to the applicant by mail. At such time and~~
9 ~~place, a designee of the board, a board member, or a board staff member selected by a~~
10 ~~majority of the board shall proceed to examine the applicant under such rules the board~~

24 ~~by said Conference of Funeral Service Examining Board of the United States, Incorporated,~~
25 ~~said board may in its discretion accept the results of said national board examination in~~
26 ~~lieu of the written portion of the board's examination.~~

27 **Section 29. That § 36-19-24 be REPEALED:**

28 ~~Any holder of a license issued by the state authority in any other state maintaining~~
29 ~~a system and standard of examination for license to engage in the practice of funeral~~
30 ~~service, which in the judgment of the State Board of Funeral Service, is substantially the~~

1 ~~equivalent to that required in this state, may be issued such a license after passing a~~
2 ~~written examination on questions concerning the laws and rules of the State of South~~
3 ~~Dakota upon the payment of the applicable fee pursuant to § 36-19-25.~~

4 **Section 30. That § 36-19-25.1 be REPEALED:**

5 ~~The receipt of fees for initial licenses issued by the Board of Funeral Service is~~
6 ~~validated and is of the same force and effect as if the board had authority to set and collect~~
7 ~~such fees.~~

8 ~~If a person has a vested right in any property because of the lack of authority~~
9 ~~referred to in this section, and if no action or proceeding to enforce such right was~~
10 ~~commenced prior to July 1, 1984, such right is forever barred, and no such action or~~
11 ~~proceeding may be brought or be of any force or effect, or be maintainable in any court~~
12 ~~of this state.~~
