House Bill 1032**AMENDMENT 1032A FOR THE INTRODUCED BILL**

1 **An Act to make an appropriation for the demolition and reconstruction of**
2 **agricultural-use structures at South Dakota State University, and to declare**
3 **an emergency.**

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

5 **Section 1.** There is hereby appropriated the sum of \$5,800,000, of other fund expenditure
6 authority, from insurance proceeds, institutional funds, and federal funds, to the Board of
7 Regents for the purposes authorized in this Act.

8 **Section 2.** The Board of Regents may demolish, remove, dispose of, reconstruct, replace, or
9 combine:

- 10 (1) The Agriculture Experiment Station Shed Hoop West 0848, at South Dakota State
11 University;
12 (2) The Agriculture Experiment Station Shed Hoop East 0849, at South Dakota State
13 University;
14 (3) The Agriculture Experiment Station Monoslope Horse Building 627, including a two
15 thousand square foot addition, at South Dakota State University;
16 (4) The Agriculture Experiment Station Sheep Unit Commodity Shed building T1300,
17 at South Dakota State University; and
18 (5) The Agriculture Experiment Station Beef Breeding North Barn T0860, at South
19 Dakota State University

20 **Section 3.** Each project listed in section 2 of this Act includes the abatement of asbestos and
21 other hazardous materials, the disposal of the fixtures and rubble, and any other action
22 necessary to restore the surface condition of the site for authorized construction.

23 The estimated total cost of the projects listed in section 2 of this Act is \$5,800,000, subject
24 to the adjustments permitted in section 4 of this Act.

1 **Section 4.** The estimated total cost stated in section 3 of this Act is in 2022 values. The
2 Board of Regents may adjust the cost estimate to reflect:

3 (1) Inflation, as measured by the Building Cost Index and reported by the Engineering
4 News Record;

5 (2) Additional expenditures required to comply with regulations adopted after the
6 effective date of this Act; and

7 (3) Additional sums received pursuant to section 1 of this Act.

8 Any adjustments to the estimated cost may not exceed one hundred twenty-five
9 percent of the estimated total cost, as set forth in section 3 of this Act.

11 **Section 5. That a NEW SECTION be added:**

12 The administration of the design and construction of the projects listed in section
13 2 of this Act are under the general charge and supervision of the Bureau of Administration,
14 as provided for in chapter 5-14.

15 **Section 6.** The executive director of the Board of Regents shall approve vouchers and the
16 state auditor shall draw warrants to pay expenditures authorized by this Act.

17 **Section 7.** Whereas, this Act is necessary for the support of the state government and its
18 existing public institutions, an emergency is hereby declared to exist, and this Act shall be in
19 full force and effect from and after its passage and approval.
