On page 1, line 4, of the Introduced bill, after "12-18-9." delete "Any person, except a candidate who is on the ballot being voted on at that polling place, may be present at any polling place for the purpose of observing the voting process. Any person may be present to observe the counting process. A candidate who is on the ballot being voted on at a polling place may only be present to cast the candidate's vote during voting hours. A number of poll watchers shall be permitted for each candidate at At a primary election, pursuant to § 12-18-8. 1, a number of poll watchers must be permitted for each

candidate. or political party and independent candidate at At a general or special election, pursuant to § 12-18-8. 1, a number of poll watchers must be permitted for each political party and independent candidate. A number of poll watchers must be permitted from each ballot question committee for an initiated or referred measure or initiated constitutional amendment at any election in which the measure or amendment appears on the ballot, pursuant to § 12-18-8. 1. "

On page 1, line 18, of the Introduced bill, after "place." insert "At a general, primary, or special election pursuant to § 12-18-8. 1, any candidate, party or ballot question committee as defined in § 12-27-1 is entitled to have a poll watcher present at any polling place for the purpose of observing the voting and counting process. This section may not apply to a candidate who is on the ballot being voted on at a polling place, and the candidate may only be present to cast the candidate's vote during voting hours.

On page 2, line 1, of the Introduced bill, after "mean:

- (1)" delete ""Ballot question committee," a person or entity that raises, collects, or distributes contributions as one of the following:
- (a) A proponent for placement on the ballot of one or more initiated or referred measures or initiated constitutional amendments;
- (b) An opponent to placement on the ballot of one or more initiated or referred measures or initiated constitutional amendments:
- (c) A proponent for the adoption of one or more initiated or referred measures or initiated constitutional amendments on the ballot;
- (d) An opponent to the adoption of one or more initiated or referred measures or initiated constitutional amendments on the ballot;"
