On page 2, after line 25, of the Introduced bill, insert: "

Section 2. That chapter 34-20A be amended with a NEW SECTION:

For the purposes of this chapter, the term, next of kin, means, in order of priority stated,
the person's:

(1) Spouse, if not legally separated;

(2) Adult son or daughter;

(3) Parent; and

(4) Adult brother or sister."

On page 3, line 27, of the Introduced bill, delete " the" and insert " a request for an examination of the person by a licensed physician or addiction counselor must be filed with the court.
The"

On page 3, line 28, of the Introduced bill, after "counselor" insert " and shall provide notice to the person whose commitment is sought of the request for an examination"

On page 3, line 30, of the Introduced bill, after "shall" insert " for a person who is detained under § 34-20A-63"

On page 4, line 1, of the Introduced bill, after "person " delete "whose commitment is sought "

On page 4, after line 27, of the Introduced bill, insert: "

Section 9. That § 34-20A-75 be AMENDED:

34-20A-75. At the hearing the court shall hear all relevant testimony, including, if possible, the testimony of at least one licensed physician ~~and or~~ one addiction counselor who ~~have~~ has examined the person whose commitment is sought."
