SB 44 (Removed from Consent) repeal provisions regarding the creation of river basin natural resource districts. (Introduced)
SB 73 (Removed from Consent) exclude road improvement district and township-owned self-propelled machinery, equipment, and vehicles from fuel excise tax. (Senate Taxation Engrossed)
SB 75 (Removed from Consent) revise provisions related to parental support for expenses related to pregnancy and childbirth. (Introduced)
SB 67 (Removed from Consent) revise provisions related to emergency and involuntary commitment for alcohol and drug abuse. (Senate Health and Human Services Engrossed)

- SB 101 provide the Department of Health with oversight authority for the provision of
emergency medical services. (Introduced)
