Picture 3) In Lamberton, MN, Summit Carbon Solutions state they will need 14 gallons of water annually. What will be Summit's water and utility usage?

Regarding CO2 pipeline companies;

- •Are they using the proposed pipeline for public use?
- •Are they transporting a commodity or a waste material?
- •Do they have proof to show you how many land owners have actually signed easements with them?
- •Who are their investors and are they foreign entities?
- •Will they wait until PHMSA has new regulations regarding these types of pipelines?
- •Do they have written safety protocols on how to rescue people and livestock when there is a rupture?

We live in Watertown and were going to build a home on the family farm in the spring of 2022. We've waited 30 years to do so. Our construction plans were halted due to the pipeline. We now have an 86 year old father living on the farm alone. We were to be living there to assist him and to carry on the family legacy of ranching and farming. Our two sons had plans of building at the farm also. The location is ideal as it is two miles south of town. It's not a large farm but the future hopes we've all had on preserving it are at risk now due to a private company, for private gain.


This last year has been absolutely devastating to our family. We had to hire a lawyer to protect property that we own. Is this what we want for South Dakota property owners to endure and sacrifice?


It is unconstitutional to have our property rights trampled on in this way.
